

ADMINISTRATIVE PROCEEDINGS

ORDER AMENDED RE PRUDENTIAL-BACHE

The Commission amended its Opinion and Order issued <u>In the Matter of Prudential-Bache</u> <u>Securities, Inc.</u>, dated January 2, 1986. That Opinion and Order provided for the retention of a consultant by Prudential-Bache and further provided that the consultant submit his report to Prudential-Bache within 180 days of the date of the Order. The Commission amended its Order to extend the time for submission of the consultant's report until July 23, 1986. (Rel. 34-23398)

CIVIL PROCEEDINGS

LIQUIDATION OF MUTUAL FUND SOUGHT

The Fort Worth Regional Office announced that on July 7 the Commaission sought appointment of a trustee to liquidate the Abrams Money Market Fund, Inc. of Dallas, Texas, an investment company not registered with the Commission. This relief is sought in a civil action instituted by the Commission in the U.S. District Court for the Northern District of Texas, charging James Travis Cornutt and four corporate defendants he allegedly controls with violating or aiding and abetting violations of the registration and antifraud provisions of the Securities Act, the antifraud provisions of the Exchange Act, Sections 203(a), 206(1) and 206(2) of the Investment Advisers Act, and Section 7(a) of the Investment Company Act. Temporary, preliminary and permanent injunctive relief is sought against all defendants, as well as temporary orders freezing assets and requiring preservation of books and records until a trustee can take control of the Fund.

On July 7 Judge Sidney A. Fitzwater granted the Commission's request for a temporary restraining order and expedited discovery but denied without prejudice the Commission's prayer for orders freezing assets and requiring preservation of books and records. Decision was deferred on the Commission's request to appoint a trustee for the Fund. (SEC v. James Travis Cornutt, et al., Civil Action No. CA-86-1815D, NDTX). (LR-11157)

INVESTMENT COMPANY ACT RELEASES

FEDERATED FUNDS

A notice has been issued giving interested persons until July 30 to request a hearing on the application filed on behalf of existing and future investment companies advised or underwritten by Federated Investors, Inc. for an order permitting the purchase of fidelity insurance from an affiliate and settlement of claims arising therefrom. THE COLORADO DOUBLE TAX EXEMPT BOND FUND, INC.

An order has been issued declaring that The Colorado Double Tax Exempt Bond Fund, Inc. has ceased to be an investment company. (Rel. IC-15197 - July 9)

HOLDING COMPANY ACT RELEASES

ARKANSAS POWER & LIGHT COMPANY

An order has been issued authorizing Arkansas Power & Light Company, subsidiary of Middle South Utilities, Inc., to issue and sell through February 28, 1987 up to \$200 million of first mortgage bonds and one or more series of its preferred stock, \$25 or \$100 par value, the total number of such shares sold not to exceed \$100 million aggregate par value. (Rel. 35-24146 - July 10) SOUTHWESTERN ELECTRIC POWER COMPANY

A supplemental order has been issued authorizing Southwestern Electric Power Company, subsidiary of Central and South West Corporation, to enter into an installment sale agreement in connection with the issuance and sale of \$81,700,000 of fixed term pollution control bonds to refund a prior series of adjustable rate bonds in the same principal amount, and releasing jurisdiction over fees, terms and conditions.
