CIVIL PROCEEDINGS

TEMPORARY RESTRAINING ORDER ENTERED AGAINST JASON SMITH PETROLEUM CORP. AND JASON SMITH

The Denver Regional Office filed a civil injunctive action on July 8 in the U.S. District Court for the Central District of California against Jason Smith Petroleum Corp. and Jason W. Smith, both of Los Angeles, California.

The Commission is seeking a temporary restraining order as well as preliminary and permanent injunctions against the defendants prohibiting them from violating the registration and antifraud provisions of the Securities Act of 1933, the antifraud provisions of the Securities Act and the Securities Exchange Act of 1934, and aiding and abetting violations of the broker-dealer registration provisions of the Exchange Act. The violations are alleged to have occurred in connection with the sale of fractional undivided production interests in oil wells to be drilled in Wyoming.

After a hearing on July 8, U.S. District Court Judge Terry J. Hatter, Jr. entered a Temporary Restraining Order, an order preventing transfer or dissipation of assets and destruction or alteration of records, freezing assets, requiring production of records, an accounting, and appointed Edward S. Gelfand as Special Officer.

A hearing on the Motion for Preliminary Injunction was scheduled for July 18 before Judge Wallace A. Tashima. (SEC v. Jason Smith Petroleum Corp., Jason W. Smith, USDC CDCA, Civil Action No. CV 86-4419-TJH [TX]). (LR-11160)

CRIMINAL PROCEEDINGS

ORDER TO SHOW CAUSE ISSUED AGAINST RICHARD HIRSCHFELD

The New York Regional Office announced that on June 26 the U.S. District Court for the Southern District of New York issued an Order to Show Cause Why Richard Hirschfeld Should Not Be Punished For Criminal Contempt and Appointing Attorneys to Prosecute. In November 1984, a Final Judgment of Permanent Injunction was issued against Hirshfeld in SEC v. Champion Sports Management, Inc. and Richard Hirschfeld, 559 F. Supp 527, SDNY, aff'd No. 84-3658 (2nd Cir. April 26, 1986). The Order enjoined Hirschfeld from violations of the antifraud provisions of the securities laws.

In its recent Application, the Commission alleged that Hirschfeld wilfully disobeyed an Order issued by the Court in August 1984, in <u>SEC v. Champion</u>, which prohibited him from making any further attempts to raise public funds for Champion. In addition, the Commission alleged that in violation of the 1984 Injunction, Hirschfeld knowingly and wilfully violated the antifraud provisions by causing Hirsch-Chemie, Ltd., a public company, to file fraudulent reports with the Commission. Hirschfeld is secretary, treasurer and a director of Hirsch-Chemie. (U.S. ex rel. SEC v. Richard Hirschfeld, 86 Crim. Misc. 1 [RJW], SDNY June 26, 1986). (LR-11159)

INVESTMENT COMPANY ACT RELEASES

WESTERN RESERVE LIFE ASSURANCE CO. OF OHIO

A notice has been issued giving interested persons until August 4 to request a hearing on an application by Western Reserve Life Assurance Co. of Ohio, WRL Series Life Account and Pioneer Western Distributors, Inc. (collectively, Applicants) for an order granting exemptions from Sections 2(a)(32), 22(c), 26(a)(2), 27(c)(1), 27(c)(2) and 27(d) of the Act and Rules 6e-3(T)(b)(12), 6e-3(T)(b)(13), 6e-3(T)(c)(2) and 22c-1. The exemptions will treat the "disability waiver" rider and the "disability waiver and income" rider as incidental insurance benefits within the meaning of Rule 6e-3(T) and to permit the deduction of an administrative charge and the premium tax in the form of a contingent deferred charge, in connection with the issuance of flexible premium variable life insurance contracts.
