ADMINISTRATIVE PROCEEDINGS

PROCEEDING AGAINST JOHN HARTUNG AND KENNETH SCHLOSSBERG SETTLED

> The Commission announced that in public administrative proceedings ordered under the Securities Exchange Act of 1934, John Hartung and Kenneth Schlossberg, both former employees of the same broker-dealer registered with the Commission (Registrant), submitted an Offer of Settlement which the Commission accepted.

On March 25, the Commission instituted public administrative proceedings against Barry Asman, Hartung and Schlossberg alleging, among other things, that Asman, from June 1981 to October 1983, Hartung, from June 1981 to December 1982, and Schlossberg, from January 1983 to October 1983, wilfully violated the antifraud provisions of the Securities Act of 1933 and the Exchange Act in that they misappropriated approximately \$1.5 million from Registrant in connection with stock borrow and stock loan transactions and falsified Registrant's books and records.

Hartung and Schlossberg consented to the Findings and Order Imposing Remedial Sanctions (Order) without admitting or denying the allegations contained therein. The Order provides for findings that Hartung and Schlossberg wilfully violated the antifraud provisions.

The Commission ordered that Hartung and Schlossberg be barred from association with any broker, dealer, investment company, investment adviser or municipal securities dealer provided that Hartung, after two years, and Schlossberg, after 18 months, may apply to become associated with such entities. CIVIL PROCEEDINGS

FINAL JUDGMENT OF PERMANENT INJUNCTION ENTERED BY DEFAULT AGAINST JAMES NEWMAN

> The Chicago Regional Office announced that on July 1 Judge John Reynolds, U.S. District Court for the Eastern District of Wisconsin, entered a Final Judgment of Permanent Injunction by Default against James Newman, enjoining him from future violations of the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934. The Final Judgment was entered after J. Newman failed to file an answer to the Commission's complaint.

> The February 27 complaint alleged that from at least January 1982 to about October 5, 1984, Newman Companies of Wis., Inc. offered and sold securities in the form of secured and unsecured promissory notes to investors raising a total of approximately \$2 million from well over 55 investors. The complaint further alleged that in connection with these sales, J. Newman, an officer of Newman Co. of Wis., made and caused to be made to investors material misrepresentations and omissions regarding: the use of investor proceeds; the financial condition of Newman Co. of Wis.; and the first mortgages on land collateralizing the secured promissory notes. INVESTMENT COMPANY ACT RELEASES

NATIONAL WESTMINSTER BANK PLC

A notice has been issued giving interested persons until August 11 to request a hearing on an application filed by National Westminster Bank PLC, an English commercial bank, for exemption from all provisions of the Investment Company Act in connection with the issuance and sale of its equity securities in the United States. IDS LIFE INSURANCE COMPANY

An order has been issued exempting IDS Life Insurance Company, IDS Life Variable Life Separate Account (Account) and Shearson Lehman Brothers Inc. (collectively, Applicants) from the provisions of Sections 12(d)(1), 26(a)(2), and 27(c)(2) of the Investment Company Act to permit the Account to offer single premium variable life insurance contracts funded by a unit investment trust comprised of stripped U.S. Treasury securities, and to permit the deduction of certain charges levied against the assets of the Account. The order also exempts Applicants from the provisions of Section 17(a) of the Act to permit certain transactions between the individual Applicants. (Rel. IC-15212 - July 21)

HOLDING COMPANY ACT RELEASES

CONSOLIDATED NATURAL GAS COMPANY

A supplemental order has been issued releasing jurisdiction previously reserved with regard to Hope Gas, Inc. in a prior Commission order dated June 16, 1986 (Rel. 35-24130) which authorized system financing transactions by Consolidated Natural Gas Company, a registered holding company, and its subsidiaries, Consolidated Natural Gas Service Company, Inc., CNG Coal Company, CNG Energy Company, CNG Research Company, The Peoples Natural Gas Company, Consolidated Gas Transmission Corporation, Consolidated System LNG Company, CNG Producing Company, West Ohio Gas Company, CNG Development Company, The East Ohio Gas Company, The River Gas Company and Hope Gas, Inc. This order authorizes the proposed transactions of Hope Gas, Inc. Jurisdiction has been reserved over The East Ohio Gas Company, The River Gas Company and The Peoples Natural Gas Company pending completion of the record. (Rel. 35-24155 - July 21)

The Commission granted accelerated approval to a proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-86-17) to increase the monthly allocations in its foreign currency options incentive program that provides financial credits to market makers based on the number of their off-floor orders. NOTICE OF PROPOSED RULE CHANGE

The Options Clearing Corporation filed a proposed rule change (SR-OCC-86-15) amending its rules to provide for access to its C/MACS on-line system by dial-up from a personal computer without the call-back feature that is currently in place. In lieu of the call-back feature, OCC proposes other multiple security features. Publication of the proposal is expected to be made in the Federal Register during the week of July 21.
