

# **INVESTMENT COMPANY ACT RELEASES**

KIDDER, PEABODY EQUITY INCOME FUND, INC.

An order has been issued on an application filed by Kidder, Peabody Equity Income Fund, Inc., and other funds managed by Kidder, Peabody & Co. Incorporated, exempting the funds from the provisions of Sections 2(a)(32), 2(a)(35), 22(c) and 22(d) of the Investment Company Act and Rule 22c-1 to permit assessment of sales charges for shares of the funds to be made on a deferred basis, including imposition of a contingent deferred sales charge (subject to waiver). ENERGY INVESTMENTS, INC.; THE CONNECTICUT LIGHT AND POWER COMPANY

Proposed rule changes have been filed under Rule 19b-4 by: <u>The Cincinnati Stock</u> <u>Exchange</u> (SR-CSE-86-5) relating to delisting by an issuer. (Rel. 34-23468); <u>The New</u> <u>York Stock Exchange</u> (SR-NYSE-86-14) that would permit it to modify listing standards for non-U.S. companies. The Commission is requesting comment on the NYSE proposal and on similar proposals by the American Stock Exchange (SR-Amex-86-6) and the National Association of Securities Dealers (SR-NASD-85-20) relating to listing standards for non-U.S. companies. Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
