CIVIL PROCEEDINGS

THE COMMERCIAL PAPER PROGRAM OF THE AMERICAN BOARD OF TRADE SERVICE CORP. FROZEN

The New York Regional Office announced that on July 18 the U.S. Court of Appeals for the Second Circuit issued an Order in <u>SEC v. The American Board of Trade, Inc., et</u> al,, freezing defendants' commercial paper program. The Court of Appeals, by its Order, lifted its stay pending appeal of a May 30 order issued by District Court Judge Kram enjoining all sales and redemptions of defendants' unregistered notes.

The Commission contended that defendants are grossly insolvent. With \$83 million in notes outstanding, as of May 19, defendants had liquid assets of only \$23 million. Judge Kram noted in her May 30 order that unless defendants' commercial paper program was frozen, all holders of commercial paper would not receive a full return on their investment.

On July 29, Judge Kram swore in Milton S. Gould, Esg. as Special Master to ascertain, among other things, the current financial condition of defendants and their affiliates. (SEC v. The American Board of Trade, Inc., et al., 86-6100, 2d Cir.; 83 Civ. 6213 [SWK] SDNY). (LR-11194)

COMPLAINT NAMES UNIWEST FINANCIAL CORPORATION

The Commission filed an injunctive action on August 14 in the U.S. District Court for the District of Columbia against Uniwest Financial Corporation of Denver, Colorado. The complaint alleges violations of the reporting provisions of the securities laws and seeks a Judgment of Permanent Injunction and Other Equitable Relief.

The Commission alleges that Uniwest, as part of a continuing course of violative conduct extending over several years, failed to file its Annual Report on Form 10-K for its fiscal year ended December 31, 1985 and its Quarterly Report on Form 10-Q for its fiscal guarter ended March 31, 1986, filed late Annual and Quarterly Reports and failed to file Notifications of Late Filing. The Commission requests that the Court order Uniwest to file its delinguent Annual and Quarterly Reports and enjoin it from further violations of the reporting provisions of the securities laws. (SEC v. Uniwest Financial Corporation, USDC DC, Civil Action No. 86-2243, August 14, 1986). (LR-11196)

INVESTMENT COMPANY ACT RELEASES

MERRILL LYNCH KECALP GROWTH INVESTMENTS LIMITED PARTNERSHIP 1983

A notice has been issued giving interested person until September 2 to request a hearing on an application filed by Merrill Lynch KECALP Growth Investments Limited Partnership 1983 and certain other entities of the Merrill Lynch organization, for an order exempting certain transactions from the provisions of Section 17(a) of the Investment Company Act, and permitting certain transactions. FEDERATED INVESTORS, INC.

An order has been issued permitting existing and future investment companies advised or underwritten by Federated Investors, Inc. to purchase fidelity insurance from an affiliate and to settle claims arising therefrom. (Rel. IC-15243 - August 11)

AMERICAN PIONEER GOVERNMENT SECURITIES FUND, INC.

SOUTHERN COMPANY

A notice has been issued giving interested persons until September 2 to request a hearing on a proposal by The Southern Company, a registered holding company, and its subsidiaries, Alabama Power Company, Georgia Power Company, Gulf Power Company, Mississippi Power Company, Southern Company Services, Inc., Southern Electric Generating Company, and Southern Electric International, Inc. (collectively, Subsidiary Companies). Southern Company will issue up to a maximum of \$6 million in value of its authorized but unissued shares of common stock in order to provide common stock to fund the Employee Stock Ownership Plan of the Southern Company System (Plan), adopted by the Subsidiary Companies, for the Plan year 1985 by direct purchase of common stock from Southern.
