ADMINISTRATIVE PROCEEDINGS

INITIAL DECISION SUSPENDS EFFECTIVENESS OF PETROFAB INTERNATIONAL REGISTRATION STATEMENT

In an initial decision, Administrative Law Judge Max O. Regensteiner issued a stop order with respect to a registration statement filed in 1984 by Petrofab International, Inc. According to the decision, Petrofab's financial statements were materially misleading in accounting for a research and development arrangement with a limited partnership by the percentage-of-completion method. The registration statement was also found deficient in failing to disclose material qualifications to the certifying accountants' consent to use of their audit report.

The initial decision is subject to Commission review on petition of a party or on the Commission's own initiative.

CIVIL PROCEEDINGS

PRELIMINARY INJUNCTIONS ENTERED AGAINST A. LEONARD VARAH AND GALEN J. ROSS

The Atlanta Regional Office announced that on July 31 U.S. District Judge John T. Nixon, Middle District of Tennessee, granted the Commission's Motion for Preliminary Injunctions against A. Leonard Varah and Galen J. Ross resulting from an evidentiary hearing held on March 13 enjoining them from further violations of the antifraud provisions of the Securities Act and the Exchange Act. The complaint alleges that commencing in 1977 and continuing until at least 1981, the defendants violated the antifraud provision in connection with the offer and sale of limited partnerships in which they had an interest and manipulated the price of Classic Mining Corporation and Living Industries, Inc. common stock through manipulative trading practices and through the issuance of numerous false and misleading press releases, shareholder communications and presentations to the public. (SEC v. Classic Mining Corporation, et al., USDC MDTN, Nashville Division, Civil Action No. 3-85-1133). (LR-11197)

AKIYOSHI YAMADA PERMANENTLY ENJOINED

The Atlanta Regional Office announced that on July 31 U.S. District Judge Robert L. Vining, Jr., Northern District of Georgia, entered a Final Judgment of Permanent Injunction against Akiyoshi Yamada who consented to the judgment without admitting or denying the allegations contained in the Commission's complaint, which charged him with violations of the antifraud provisions of the securities laws.

The complaint alleged that in connection with the offer and sale of units consisting of common stock and warrants of Nutri-Health Centers, Inc. under a Form S-18 registration statement, Yamada (who had been enjoined from violating the securities laws previously) made misrepresentations and omissions concerning his role and association with Nutri-Health, the financial problems of Nutri-Health and the status of Nutri-Health's business operations. (SEC v. Nutri-Health Centers, Inc., et al., Civil Action No. C86-968A, USDC NDGA, filed April 30, 1986). (LR-11198)

CRIMINAL PROCEEDINGS

JAMES MCGOVERN CONVICTED

Francis X. Hermann, U.S. Attorney for the District of Minnesota, and the Chicago Regional Office announced that on August 7 James Francis McGovern, former legal counsel to Flight Transportation Corporation, was sentenced to six years imprisonment by Chief Judge Donald Alsop. McGovern had been previously convicted of two counts of violations of the antifraud provisions in connection with Flight's 1981 securities offering. (U.S. v. James Francis McGovern, USDC DMN, Criminal No. 3-85-95). (LR-11199)

INVESTMENT COMPANY ACT RELEASES

APPLICATION BY JOHN J. FLYNN FOR EXEMPTIVE RELIEF

A notice has been issued giving interested persons until September 17 to request a hearing on an application by John J. Flynn requesting a permanent exemption from the prohibitions of Section 9(a) of the Investment Company Act operative as a result of an injunction entered against him in SEC v. Edward J. Falvey, et al. (Rel. IC-15253 - August 14)

EL PASO FUNDING CORPORATION

An order has been issued exempting El Paso Funding Corporation from all provisions of the Investment Company Act to permit it to issue and sell debt securities as part of the financing of an undivided interest owned by El Paso Electric Company in a nuclear generating station. (Rel. IC-15254 - August 15)

THE EVERGREEN TOTAL RETURN FUND, INC.

A notice has been issued giving interested persons until September 8 to request a hearing on an application filed by The Evergreen Total Return Fund, Inc. (Fund), Saxon Woods Asset Management Corp. and Lieber & Company, requesting an order granting a retroactive exemption from all provisions of the Investment Company Act for certain transactions relating to an overissuance of Fund shares. HOLDING COMPANY ACT RELEASES

VERMONT YANKEE NUCLEAR POWER CORPORATION

An order has been issued authorizing Vermont Yankee Nuclear Power Corporation, an indirect subsidiary of the New England Electric System and Northeast Utilities, to exchange up to \$56.3 million aggregate principal amount of three series of first mortgage bonds for three new series of bonds in the same principal amount. The tender offer will solicit modifications to the indenture. Jurisdiction was reserved over the terms and conditions of the new bonds. (Rel. 35-24169 - August 18)

SELF-REGULATORY ORGANIZATIONS

NOTICE OF PROPOSED RULE CHANGE

The National Association of Securities Dealers, Inc. filed a proposed rule change under Rule 19b-4 (SR-NASD-86-20) which would amend the Board of Governors' Interpretation with respect to "Free-Riding and Withholding" under Article III, Section 1 of the Rules of Fair Practice. The amendment would provide limited exemptive relief to certain members desiring to purchase publicly offered securities issued in connection with the conversion of savings and loan associations and certain other organizations from a mutual to a stock form of ownership. Publication of the proposal is expected to be made in the Federal Register during the week of August 18. (Rel. 34-23538)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the National Securities Clearing Corporation (SR-NSCC-86-8) that establishes the Stock Loan Rebate Payment and Collection Service. The proposal will enable NSCC to provide a centralized and automated mechanism for the payment and collection of stock loan rebates. (Rel. 34-23539)
