

ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST TLS FINANCIAL SERVICES, INC. AND TRACY L. SUNDERLAGE

The Commission instituted public administrative proceedings against TLS Financial Services, Inc., a registered investment adviser, and Tracy L. Sunderlage, its president. Simultaneously, the Commission accepted offers of settlement in which they consented, without admitting or denying, to findings by the Commission and in which TLS consented to the revocation of its investment adviser registration and Sunderlage consented to a bar from association with any broker, dealer, investment adviser, investment company or municipal securities dealer with the right to reapply in a supervised capacity after two years and three months. The Commission found that TLS and Sunderlage wilfully violated and Sunderlage wilfully aided and abetted TLS's violations of the registration and antifraud provisions of the Securities Act, the Securities Exchange, and the Investment Advisers Act. The violative conduct centered on making material misstatements or omissions in connection with the recommendation, offer and sale of securities issued by Caprimex, Inc., located in Holland, concerning, among other things, the risks and expected return; the potential conflict of interest between roles as an investment adviser and a Caprimex securities salesman; the scope and extent of the due diligence investigation; and registration as an investment adviser. CIVIL PROCEEDINGS

TLS FINANCIAL SERVICES INC. AND TRACY L. SUNDERLAGE ENJOINED

The Chicago Regional Office announced that on August 18 Judge Nicolas Bua, U.S. District Court for the Northern District of Illinois, entered Orders of Permanent Injunction enjoining TLS Financial Services, Inc., a registered investment adviser, and Tracy L. Sunderlage, its president, from violating the securities, broker-dealer and investment adviser registration and antifraud provisions of the securities laws. The defendants consented to the injunctions without admitting or denying the allegations in the Commissions's complaint.

The complaint alleged that from about August 1980 to July 1984, TLS and Sunderlage offered and sold unregistered securities issued by Caprimex, Inc., a subsidiary of Caprimex Holdings S.A. located in Luxembourg, while acting as brokers, and for a portion of the period as investment advisers, without registering as such with the Commission. The complaint also alleged that TLS and Sunderlage made material misstatements and omissions in connection with the recommendation, offer and sale of securities issued by Caprimex, concerning, among other things, the risks and expected return; the potential conflict of interest between roles as an investment adviser and a Caprimex securities salesman; the scope and extent of the due diligence investigation; and registration as an investment adviser. INVESTMENT COMPANY ACT RELEASES

ACACIA NATIONAL LIFE INSURANCE COMPANY

HOLDING COMPANY ACT RELEASES

GENERAL PUBLIC UTILITIES CORPORATION

A notice has been issued giving interested persons until September 15 to request a hearing on a proposal by General Public Utilities Corporation, a registered holding company, and its subsidiaries, Jersey Central Power & Light Company, Metropolitan Edison Comapny and Pennsylvania Electric Company (collectively, GPU Companies) to: (1) issue, sell and renew to certain banks from time to time through March 31, 1989, their respective unsecured promissory notes (New Notes) up to an aggregate principal amount of \$110 million, pursuant to a new revolving credit agreement; and (b) to issue and sell or renew their respective unsecured promissory notes to various banks pursuant to informal lines of credit in amounts which, when added to such GPU Companies total principal amount of New Notes than outstanding, would not exceed the amount of short-term indebtedness permitted by such company's charter to be outstanding at any one time.
