COMMISSION ANNOUNCEMENTS

EDGAR CONTRACT BIDS EXTENDED

The Securities and Exchange Commission announced today extension of the date for the submission of bids on the operational Edgar electronic disclosure system from September 10th to December 31st.

The extension is to consider comments from potential bidders and others, including the possibility of scheduling payments to coincide more closely with the contractor's expenditures, permitting shared or dedicated off-site facilities and extending the seven year term of the contract. Any changes in the Request for Proposals will be published by October 31st in order to permit potential contractors to consider the impact on their bids. The pilot program will continue until the operational system begins.

INVESTMENT COMPANY ACT RELEASES

IDS SPECIAL TAX-EXEMPT SERIES TRUST

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Municipal Securities Rulemaking Board filed a proposed rule change (SR-MRSB-86-11) which became effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposal provides an interpretation of Rule G-33 on calculations explaining the appropriate method of calculating price from yield in transactions involving securities that have an initial non-interest paying period and then pay interest on a periodic basis until redemption. (Rel. 34-23569)

APPROVAL OF PROPOSED RULE CHANGES
