INVESTMENT COMPANY ACT RELEASES

SWISS BANK CORPORATION AND SBC FINANCE (DELAWARE) INC.

AMERICAN ELECTRIC POWER SERVICE CORPORATION; NORTHEAST UTILITIES; KENTUCKY POWER COMPANY

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed by: the <u>Philadelphia Stock</u> <u>Exchange, Inc.</u> (SR-Phix-86-16) to narrow the maximum allowable bid-ask differential in nine and twelve-month term series of foreign currency options except for options on the European Currency Unit (Rel. 34-23583); and the <u>Chicago Board Options Exchange,</u> <u>Incorporated</u> (SR-CBOE-86-13) to provide one-year access to its foreign currency options markets and short and long-term incentives to encourage marketmakers and floor brokers to trade currency options (Rel. 34-23584).

TRUST INDENTURE ACT RELEASES

OGLETHORPE POWER CORPORATION

A notice has been issued giving interested persons until September 22 to request a hearing on an application by Oglethorpe Power Corporation, a Georgia corporation, under the Trust Indenture Act of 1939. The application declares that the trusteeship of Trust Company Bank (under nine separate trust indentures under which pollution control bonds were issued and a new indenture dated September, 1986, under which it is proposed to issue serial facility bonds of the company) is not likely to involve a material conflict of interest making it necessary in the public interest or for the protection of investors to disgualify Trust Company Bank from acting as trustee under these indentures.
