

CRIMINAL PROCEEDINGS

JOSEPH GRIGGS III PLEADS GUILTY

The Department of Justice and the Commission announced that on September 5 Joseph Griggs III, of Roanoke, Virginia, pled guilty in the Roanoke Federal Court to a threecount Information that included one count of obstruction of justice and two counts of filing false federal income tax returns for 1980 and 1981. The Information charged that Griggs organized and promoted 77 limited partnerships to investors to build housing subsidized by the U.S. Department of Housing and Urban Development. Approximately \$7,152,513 was obtained from investors for the limited partnerships. Griggs received fees for architectural and other services performed for the housing projects by a firm which he owned.

As a part of the fraudulent scheme, Griggs shredded a document subject to a Grand Jury subpoena, had his controlled entities buy and sell real estate among themselves in order to create an artificial loss of \$613,416 for tax purposes, and claimed a \$128,728 partnership tax loss for an entity which was not a limited partner.

Sentencing will be at a later date. (U.S. v. Joseph Griggs III, USDC WDVA, Criminal Action No. 86-00064). (LR-11215)

INVESTMENT COMPANY ACT RELEASES

IDS LIFE INSURANCE COMPANY

A notice has been issued giving interested persons until October 1 to request a hearing on an application filed by IDS Life Insurance Company, IDS Life Variable Account for Shearson Lehman (Account) and Shearson Lehman Brothers, Inc. for an order granting exemptions from the provisions of Sections 2(a)(32), 2(a)(35), 12(d)(1), 22(c), 26(a), 27(c)(1), 27(c)(2), 27(d) and 27(f) of the Investment Company Act and Rules 6e-2(b)(1), 6e-2(b)(12), 6e2(b)(13), 6e-2(c)(1), 6e-2(c)(4), 22c-1 and 27f-1. The exemptions will permit the Account to offer single premium variable life insurance contracts funded, in part, by a unit investment trust comprised of stripped U.S. Treasury securities, and to permit the deduction of certain charges levied against the assets of the Account. The application also requests an order exempting Applicants from the provisions of Section 17(a) of the Investment Company Act to permit certain transactions between the individual Applicants. (Rel. THE PRUDENTIAL INSURANCE COMPANY OF AMERICA

An order has been issued granting The Prudential Insurance Company of America, et al., exemptions from Sections 2(a)(32), 22(c), 22(d), 26(a)(2), 27(c)(1), 27(c)(2) and 27(d) of the Investment Company Act of 1940 and Rule 22c-1 to permit Prudential to issue variable annuity contracts providing for a recapturable bonus equal to 1% of certain purchase payments. HOLDING COMPANY ACT RELEASES

THE SOUTHERN COMPANY

A notice has been issued giving interested persons until October 6 to request a hearing on a proposal by The Southern Company, a registered holding company, to acquire the common stock of two nonaffiliated off-shore companies for a total investment not exceeding \$5,000,000 in either case in order to obtain liability insurance from such companies' wholly owned subsidiaries. In connection with the purchase of other insurance, Southern also proposes to acquire shares of other companies for a total investment not exceeding \$10,000,000. The Commission is requested to reserve jurisdiction over this aspect of the application pending completion of the record. It is stated that Southern will at no time acquire, directly or indirectly, common shares of any company in amounts resulting in the ownership of 5% or more of the outstanding voting shares of any such company. ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

LTV CORPORATION

A notice has been issued giving interested persons until October 6 to request a hearing on an application by LTV Corporation under Section 310(b)(1)(ii) of the Trust Indenture Act of 1939. The application declares that the successor trusteeship of Texas American Bank/Dallas under previously qualified indentures dated January 15, 1968, September 15, 1968, March 1, 1969 and July 1, 1977 is not so likely to involve a material conflict of interest as to make it necessary to disqualify Texas American Bank/Dallas from acting as trustee.
