COMMENT PERIOD EXTENDED ON TOPICS RELATING TO TAKEOVER AND CONTESTS FOR CORPORATE CONTROL

The Commission has extended the public comment period on three topics relating to takeovers and contests for corporate control: (1) whether the Williams Act should apply whenever a person acquires a substantial percentage of a target company's securities during or shortly after a tender offer; (2) whether there should be a governmen-tal response to the proliferation of "poison pill" plans; and (3) whether the Commission should adopt a self-governance exemption to its "all holders" rule, as well as to other provisions of its tender offer rules. Interested persons are directed to Rel. 34-23486 (July 31, 1986) for a full discussion of these topics. The comment period, which was originally scheduled to expire on September 30, 1986, has been extended to December 1, 1986. (Rel. 34-23643)

COMMISSION ANNOUNCEMENTS

BDWIN J. TOMKO APPOINTED CHIEF, OFFICE OF CRIMINAL REFERENCE

> The Commission today announced the appointment of Edwin J. Tomko to be Chief of the Office of Criminal Reference within the Division of Enforcement. The Office of Criminal Reference will operate as a liaison with the Department of Justice, the United States Attorneys, and other various criminal investigative agencies to facilitate action on Commission referrals and to provide technical advice where appropriate.

> Mr. Tomko has spent the last three years as Assistant Regional Administrator in charge of the Commission's Houston Branch Office. Prior to that, he was a trial attorney in, and later Special Counsel to the Chief of, the Fraud Section of the Department of Justice in Washington.

A 1965 graduate of Washington and Jefferson College, Mr. Tomko earned a J.D. from Vanderbilt University School of Law in 1968.

COLLEEN P. MAHONEY NAMED ASSISTANT GENERAL COUNSEL

Colleen P. Mahoney has been named Assistant General Counsel (Litigation and Administrative Practice) of the Office of the General Counsel. Ms. Mahoney joined the Commission as a staff attorney in the Office of the General Counsel in 1983. Prior to joining the Commission, Ms. Mahoney was at the law firm of Steptoe & Johnson in Washington, DC.

Ms. Mahoney received her J.D. degree, summa cum laude, from The American University, Washington College of Law, in 1981, where she was a member of The American University Law Review. She received a B.A. degree in Political Science, magna cum laude, from The American University in 1978.

ADNINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST SHEARSON LEHMAN BROS., INC. AND STEIN ROE & FARNHAM

The Commission instituted public administrative proceedings against Shearson Lehman Bros., Inc., a registered broker-dealer, and Stein Roe & Farnham, a registered investment adviser. The Order alleges that Shearson and Stein Roe failed to reasonably

supervise George and John Inserra, Nicholas J. Gentile, and John Giura, respectively, with a view to preventing violations of the antifraud provisions of the Investment Advisers Act of 1940 and the Securities Exchange Act of 1934.

In separate proceedings, which are being contested, the Commission alleged that Giura, the Inserras and Gentile engaged in various schemes to defraud clients of Shearson and Stein Roe, including union pension and welfare funds. The Order herein alleges that Shearson's procedures were not sufficient to prevent the violations by Gentile and the Inserras, and that Stein Roe had no procedures in place that would have reasonably prevented Giura's violations.

Simultaneous with the institution of proceedings, Shearson and Stein Roe, without admitting or denying the Commission's allegations, consented to the Order, a censure, and the appointment of independent consultants to review and report upon their procedures. Both Shearson and Stein Roe consented to implement any recommendations resulting therefrom. (Rel. 34-23640)

CRIMINAL PROCEEDINGS

LEE SHROUT AND RALPH ERNSTSEN SENTENCED

The Los Angeles Regional Office and the U.S. Attorney's Office for the Central District of California announced that on September 8 Judge Manuel E. Real sentenced Lee R. Shrout to two years in prison, placed him on five years probation, and ordered him to perform 1,500 hours of community service. Judge Real also sentenced Ralph Ernstsen to six months in prison, placed him on five years probation, fined him \$10,000, and ordered him to perform 1,500 hours of community service. Sentencing for a third defendant, E. Michael Furlong, was postponed until October 20, 1986. In July 1986, the defendants pleaded guilty to securities and mail fraud in connection with a scheme to manipulate ABEX, Ltd. common stock. According to the indictment, which was the result of a joint investigation by the Commission and the U.S. Attorney's Office, from October 1983 and January 1984 the defendants manipulated the over-the-counter market for ABEX from \$.10 to over \$5 a share.
