The subject matter of the October 15 closed meeting will be: Withdrawn institution of administrative proceeding of an enforcement nature; Institution of injunctive actions. Settlement of injunctive action; Regulatory matter regarding self-regulatory organiza-tion.

#### OPEN MEETING - THURSDAY, OCTOBER 16, 1986 - 10:00 a.m.

The subject matter of the October 16 open meeting will be:

(1) Consideration of whether to propose for comment: (a) new Rule 430A under the Securities Act of 1933 and a related amendment to Item 512 of Regulation S-K, which, if promulgated, will eliminate the filing of many pricing amendments by permitting registration statements to be declared effective without disclosing the price, certain price-related information and information concerning the underwriting syndicate; (b) amendments to Rules 424(b) and 497 to require more immediate filing of the prospectus where the procedure outlined in proposed Rule 430A has been employed; and (c) other amendments to Rule 424 which would be applicable to other prospectuses and would eliminate unnecessary filings, provide for classification of prospectuses according to the nature of the information being modified or added, and reduce the filing period for prospectuses used after the effective date. (2) Consideration of whether to issue a release adopting amendments to Securities Exchange Act Rule 15c3-1 that would expand the types of instruments that could be used to create a hedged position in highly rated corporate debt securities. The amendments would also lower the deductions from net worth in arriving at net capital for hedged corporate debt securities positions and would redefine the criteria for determining whether the maturities of two offsetting positions are close enough to consider the combined corporate debt securities position as hedged for purposes of Rule 15c3-1. (3) Consideration of whether to approve rule proposals submitted by the American Stock Exchange, Inc. and the New York Stock Exchange, Inc. # **CIVIL PROCEEDINGS**

CHAROLETTE AND EDWARD GARRITY IMPRISONED FOR CIVIL CONTEMPT

> The Chicago Regional Office announced that on September 16 Judge Robert A. Grant, U.S. District Court for the Northern District of Indiana, South Bend Division, ordered that Charolette and Edward Garrity be imprisoned for civil contempt for their failure to disgorge as ordered \$295,049 collected from investors in connection with a program they operated known as International Diversified Corporation or IDC. On July 3, the Garritys were held in civil contempt of the October 5, 1984 Order of Preliminary Injunction, previously entered against them, in connection with their fraudulent offer and sale of the unregistered IDC securities. The Garritys were ordered to disgorge \$295,049 collected from IDC investors by September 16. They failed to comply with the Court's July 3 order and failed to prove that it was impossible for them to comply with the Court's order; consequently, they were ordered to be imprisoned. (SEC v. ## **CRIMINAL PROCEEDINGS**

RICHARD HIRSCHFELD PLEADS GUILTY TO CRIMINAL CONTEMPT

The New York Regional Office announced that on September 29 Richard Hirschfeld pled guilty to criminal contempt in U.S. ex rel. SEC v. Richard Hirschfeld. This crmiinal action arose from the Commission's prior civil action against Hirschfeld. In November 1984 in SEC v. Champion Sports Management, Inc. and Richard Hirschfeld, Hirschfeld was permanently enjoined from violations of antifraud provisions of the securities laws.

On June 26, the Commission's application for an Order to Show Cause was granted, charging that Hirschfeld had wilfully violated the Champion injunction and an earlier Court bench order.

On September 29, Hirschfeld withdrew his earlier plea of not guilty and pled guilty to failing to disclose the Champion injunction in the 1984 and 1985 Annual Reports filed with the Commission by Hirsch-Chemie Limited, a public company located in Virginia of which he was an officer and director. Sentencing is scheduled for November 14. (U.S. ex rel. SEC v. Richard Hirschfeld, 86 Cr. Misc. 1 [RJW], SDNY, September 29, 1986). (LR-11239)

# INVESTMENT COMPANY ACT RELEASES

PVNGS FUNDING CORP., INC.

## HOLDING COMPANY ACT RELEASES

GENERAL PUBLIC UTILITIES CORPORATION

An order has been issued authorizing General Public Utilities Corporation, a registered holding company, and its subsidiaries, Jersey Central Power & Light Company, Metropolitan Edison Company and Pennsylvania Electric Company (collectively, GPU Companies), to issue, sell, and renew to certain banks from time to time through March 31, 1989 their respective unsecured, short-term promissory notes (New Notes) in an aggregate principal amount up to \$110 million at any one time outstanding, under a new revolving credit agreement. The GPU Companies are also authorized to issue or renew their respective unsecured, short-term promissory notes to various commercial banks by informal lines of credit. The amount of such promissory notes of a given GPU Company, when added to that Company's total principal amount of New Notes then outstanding, would not exceed the amount of short-term indebtedness permitted by the Company's charter to be outstanding at any one time.
