U.S. SECURITIES AND EXCHANGE COMMISSION

## ADMINISTRATIVE PROCEEDINGS

### PROCEEDINGS INSTITUTED AGAINST SUNLIN WONG

The Commission instituted public administrative proceedings under Section 203(f) of the Investment Advisers Act of 1940 against Sunlin L.S. Wong, formerly the president of Bishop, Baldwin, Rewald, Dillingham & Wong, an investment adviser whose registration the Commission was revoked in 1984. The Order alleges that Wong was convicted in October 1984 in the U.S. District Court for the District of Hawaii for mail and securities fraud.

Simultaneously, Wong submitted an Offer of Settlement which the Commission accepted. Wong consented to an Order barring him from association with any investment adviser, broker, dealer, or municipal securities dealer. (Rel. IA-1042)

### FRANK MANDERS PERMANENTLY BARRED

The Commission imposed a permanent bar with the right to reapply in five years against Frank Manders in accordance with his Offer of Settlement. Manders consented to the findings that: (1) from January 1983 to November 1984, he was successively employed by two broker-dealers; and (2) on April 24, 1986, a permanent injunction by default was entered against him, enjoining him from future violations, as a principal or aider and abettor, of the registration and antifraud provisions of the Securities Act of 1933 and the antifraud provisions of the Securities Exchange Act of 1934. ## **CRIMINAL PROCEEDINGS**

### FORMER HOME STATE PRINCIPALS INDICTED

The Atlanta Regional Office and the U.S. Attorney for the Southern District of Ohio announced that on October 2 a federal grand jury returned a 31-count indictment against Marvin L. Warner, former owner of Home State Savings Bank, and Burton M. Bongard, Home State's former President and Chairman. Warner was charged with conspiracy, 16 counts of wire fraud, and two counts of interstate movement of money taken by fraud. Bongard was charged with conspiracy, 13 counts of wire fraud, and two counts of interstate movement of money taken by fraud.

The indictment charges that between about March 21, 1980 and about March 9, 1985, Warner, Bongard, and other co-conspirators participated in a scheme to defraud Home State's depositors, its debenture holders, and Ohio regulatory officials. It is alleged that Warner and Bongard caused Home State to make and maintain investments with E.S.M., a Florida government securities dealer that was placed in receivership in March 1985. It is further alleged that in exchange for these investments, E.S.M. gave Home State, Warner, and Bongard favorable treatment, and that Warner and Bongard fraudulently received funds totalling no less than \$5 and \$3 million, respectively, which were disguised and concealed as legitimate trading profits. (U.S. v. Marvin L. Warner and Burton M. Bongard, Indictment No. CR 1 86-0106, SDOH; indictment returned October 2, 1986). (LR-11274)
