## **RULES AND RELATED MATTERS**

PROXY AND OTHER RULES AMENDED

The Commission has adopted amendments to its proxy rules and certain other rules, which will be effective 60 days after publication in the Pederal Register, although compliance is permitted upon publication. Amendments to Items 11 through 14 of Schedule 14A bring to the proxy rules the benefits of the integrated disclosure system. The amendments also include a compensation plan disclosure item, Item 10 of Schedule 14A, that streamlines and simplifies proxy disclosure previously required. In addition, the amendments to Item 9 of Schedule 14A, Item 304 of Regulation S-K and Form S-18 require those engaged in initial public offerings and registrants not subject to Exchange Act reporting requirements at the time of a change in accountants to provide disclosure concerning the change and any related disagreements.

#### PROPOSED AMENDMENTS TO PROXY AND OTHER RULES

The Commission has published for comment amendments to Item 14 of Regulation 14A to further conform the proxy disclosure for mergers and similar transactions to that required for registration of securities in certain business combinations. The Commission also published for comment a new proposed Rule 14a-14 under the Securities Exchange Act of 1934 which would specify the treatment of a statement in a document incorporated by reference that is subsequently modified or superseded by a statement in a later document also incorporated by reference. In addition, the Commission published for comment revisions which clarify the time a proxy statement or prospectus must be sent and the application of the disclosure requirements concerning changes in accountants.

# **ADMINISTRATIVE PROCEEDINGS**

JOHN KEVIN O'NEILL BARRED

The Commission entered an Order barring John Kevin O'Neill, a former registered representative with Merrill Lynch, Pierce, Penner & Smith, Inc. in Napa, California, from future association with any broker or dealer. The Commission's Order Imposing Sanctions was entered by default after O'Neill failed to answer both the Commission's Order for Public Proceeding and the Division of Enforcement's Motion for a Default.

The allegations in the Order for Proceedings were based upon a felony conviction entered against O'Neill in the federal district court for the Northern District of California after O'Neill pled guilty to two counts of wire fraud relating to misap propriation of a client's funds while acting as a registered representative. O'Neill was sentenced to four years imprisonment, to be followed by five years probation. (Rel. 34-23756)

GULF POWER COMPANY CONSOLIDATED NATURAL GAS CO.

Gulf Power Company (Gulf) and Mississippi Power Company (Mississippi) - electric utility subsidiaries of The Southern Company, whereby Mississippi, acting for itself and as agent for Gulf, would terminate certain existing coal supply contracts (Contracts) and would enter into a new agreement with a special purpose corporation for the supply of coal to an electric generating facility jointly owned by Gulf and Mississippi. Gulf will be responsible for one-half of all costs incurred by Mississippi.

Alternatively, Gulf and Mississippi propose that each of their short-term borrowing authorizations be increased by \$65 million to permit interim financing for the termination of the Contracts; and
