## **ADMINISTRATIVE PROCEEDINGS**

NASD ACTION AGAINST LOWELL H. LISTROM & COMPANY, INC. AND LOWELL H. LISTROM AFFIRMED

The Commission affirmed sanctions imposed by the NASD on Lowell H. Listrom & Company, Inc., a Kansas City brokerage firm, and Lowell H. Listrom, its president. The NASD censured the firm and Listrom, fined him \$5,000, jointly and severally, and suspended them from participating in any underwriting for 30 days.

The Commission found, as had the NASD, that in connection with the firm's 1982 "best efforts" underwriting of common stock of International Tours, Inc., respondents failed to record certain subscription sales to customers and to send those customers confirmations. The Commission also found that respondents improperly extended credit to certain customers who purchased stock in the International offering.

In affirming the sanctions imposed by the NASD, the Commission noted that respondents had "a lengthy history of prior infractions." It observed that respondents' repeated violations indicated "the need for sanctions severe enough to deter further misconduct, and to impress on [respondents] the need for scrupulous compliance in the future." ### CIVIL PROCEEDINGS

PERMANENT INJUNCTION ENTERED AGAINST R. L. SMITH AND ASSOCIATES, INC.

The Los Angeles Regional and San Francisco Branch Offices announced that on October 7 U.S. District Judge Marilyn Hall Patel, Northern District of California, entered an order of permanent injunction against R. L. Smith and Associates, Inc., now known as R. A. Johnson and Company, Inc. The defendant, a securities brokerage firm in Salt Lake City, Utah, consented to the permanent injunction without admitting or denying the allegations in the complaint. The final order enjoins the defendant from violating the registration, antifraud and antimanipulative provisions of the securities laws and from trading in any security in violation of a trading suspension ordered by the Commission.

The complaint alleged that from 1983 through 1984 the firm violated the registration and antifraud provisions of the securities laws in the offer and sale of securities of Gay International, Inc., a San Francisco-based corporation. It further alleged that the firm violated the antimanipulative prohibitions and a Commission order suspending trading in the securities of Gay International. (SEC v. Gay International, Inc., et al., Civ. No. C-84-5997 MHP, NDCA). (LR-11281)
