CIVIL PROCEEDINGS

JASON SMITH PETROLEUM CORPORATION AND JASON SMITH ENJOINED

The Denver Regional Office announced that on November 7 Judge Terry J. Hatter, U.S. District Court for the Central District of California, entered an Order permanently enjoining Jason Smith Petroleum Corporation and Jason Smith from further violating the registration, antifraud, and broker-dealer registration provisions of the securities laws. The Court further ordered the defendants to pay for an accounting by a certified public accountant by December 7 identifying investors, amounts of funds raised, and the use and disbursement of funds; and ordered defendants to send a summary of the accounting report to each investor.

The July 8 complaint alleged that in the offer and sale of unregistered oil and gas securities, defendants violated the above provisions of the securities laws. In the complaint, the Commission sought injunctive and other ancillary relief including disgorgement against the defendants. The request for disgorgement and determination of the amount of disgorgement are issues that remain unresolved. (SEC v. Jason Smith Petroleum Corporation, et al., USDC CDCA, Civil Action No. CV-86-4419-TJH [Tx]). (LR-11293)

CAPITAL SUNBELT INVESTMENT, INC., OTHERS ENJOINED

The Atlanta Regional and Miami Branch Offices announced that on November 4 the U.S. District Court for the Middle District of Florida entered Final Judgments of Permanent Injunction against Capital Sunbelt Investments, Inc., Capital Sunbelt Securities, Inc., Silas T. Patrick, and John D. Burkey, enjoining them from further violations of the registration and antifraud provisions of the Securities Act of 1933 and the antifraud provisions of the Securities Exchange Act of 1934. The Final Judgments also enjoined Capital Sunbelt Securities from further violations of, and Patrick and Burkey from further aiding and abetting violations of, the broker-dealer antifraud provisions of the Exchange Act. The defendants consented to the Final Judgments without admitting or denying the allegations contained in the Commission's complaint. The complaint alleged violations of the registration and antifraud provisions of the securities laws in the offer and sale of real estate limited partnerships, as well as violations and aiding and abetting violations of the broker-dealer antifraud provisions. (SEC v. Capital Sunbelt Investments, Inc., et al., MDFL, Civil Action No. 86-1509-CIV-T-15A). (LR-11294)

INVESTMENT COMPANY ACT RELEASES

SUN LIFE ASSURANCE COMPANY OF CANADA (U.S.)

An order has been issued to Sun Life Assurance Company of Canada (U.S.) et. al. (Applicants) granting exemptions from Sections 2(a)(32), 2(a)(35), 9(a), 13(a), 15(a), 15(b), 22(c), 26(a)(1), 26(a)(2), 27(a)(1), 27(c)(2), 27(d) and 27(f) of the Investment Company Act and Rules 6e-2(b)(1), 6e-2(b)(12), 6e-2(b)(13), 6e-2(b)(15), 6e-2(c)(1), 6e-2(c)(4), 22c-1 and 27f-1 to the extent necessary to permit the issue and sale by Applicants of single premium variable life insurance contracts containing provisions for a contingent deferred sales load, charges against the assets of the separate account for the cost of a minimum death benefit guarantee as well as the cost of insurance protection based on the 1980 CSO Table and for substandard extras under certain circumstances, the contractowner bearing the risk of separate account investment performance during the "free look" period, the separate account to hold investment securities in book-entry form without a formal trustee, and the separate account to purchase such securities from a fund offering its securities to annuity separate accounts affiliated with the Applicants. FAMILY LIFE INSURANCE COMPANY

A notice has been issued giving interested persons until December 11 to request a hearing on an application by Family Life Insurance Company, et al., requesting an order approving substitutions of certain securities issued by an open-end management investment company and held by a separate account of Family Life in order to preserve the current tax status of certain variable annuity contracts funded by the separate account in light of temporary regulations issued recently by the Internal Revenue Service.
