CIVIL PROCEEDINGS

COMPLAINT FILES AGAINST MELVIN N. POMERANTZ

The Commission filed a complaint on December 11 in the U.S. District Court for the Southern District of New York against Melvin N. Pomerantz, a businessman in the San Antonio, Texas area, alleging that he violated the antifraud provisions of the Securi-ties Exchange Act of 1934 in connection with trading in the securities of SFN Companies, Inc. The complaint alleges that one day prior to the public announcement of a proposed leveraged buyout of SFN, Pomerantz, in breach of a duty of trust and confidence, misappropriated material nonpublic information concerning the buyout offer for SFN. Pomerantz, the complaint alleges, traded while in possession of the information and recommended the stock to his mother-in-law. Without admitting or denying the allegations of the complaint, Pomerantz consented to a permanent injunction, to disgorge both his and his mother-in-law's combined profits of \$39,925, and agreed to pay a penalty of \$79,850 under the Insider Trading Sanctions Act of 1984.
