ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST JACK R. MATHIAS AND MARTIN L. DOWNEN

The Commission issued an order instituting administrative proceedings, making findings, and imposing remedial sanctions against Jack R. Mathias and Martin L. Downen. The respondents consented to the administrative order without admitting or denying violations. The order alleges that the respondents wilfully violated the registration, antifraud, and broker-dealer registration provisions in connection with limited partnership offerings. As an additional basis for the proceeding, the order alleges the October 10 and 14 entries of orders against Mathias and Downen enjoining them from further such violations of the securities laws. Respondents were suspended from associating with a broker or dealer in any capacity for nine months and barred from employment or affiliation with a broker or dealer in any supervisory capacity for five years. CIVIL PROCEEDINGS

THOMAS C. FITZGERALD PAYS \$75,000 CIVIL CONTEMPT FINE

The Commission announced that pursuant to a Stipulation and Order entered on December 15 by the U.S. District Court for the District of Columbia Thomas C. Fitzgerald, Jr., of Marietta, Georgia, paid a \$75,000 fine for civil contempt. The payment is the first of a series to satisfy a \$143,000 fine assessed by the Court on April 9, 1984. The Court ordered Fitzgerald to pay the \$68,000 balance of his fine, with interest, by paying one quarter of his adjusted gross income (net of federal and state income taxes) each year commencing with any federal income tax return filed after January 1, 1987. The Court's Order provides that Fitzgerald shall be incarcerated in the event he fails to pay the balance of the fine.

Fitzgerald made the \$75,000 payment in settlement of the Commission's May 21, 1986 motion to incarcerate him for failure to pay the previously assessed fine (LR-10335). He was found in civil contempt on August 29, 1984 for failure to pay the fine (LR-10516). (SEC v. Diversified Growth Corporation, et al., USDC DC, Civil Action No. 81-0084 [1981]). (LR-11308)

CRIMINAL PROCEEDINGS

CHARLES BYERS SENTENCED

The Philadelphia Regional Office and the U.S. Attorney's Office for the Western District of Pennsylvania announced that on November 26 Charles Byers, of Monongahela, Pennsylvania, was sentenced to five years in prison followed by five years probation. On September 24, Byers pled guilty to two counts of a 30-count indictment for mail fraud. The indictment alleged that Byers operated a Ponzi scheme from June 1982 until November 20, 1984, in which approximately 395 investors invested more than \$1,386,870 and suffered a combined loss of approximately \$919,966. Byers previously consented to a permanent injunction in a Commission action arising out of the same activity in which he also paid over to the Registry of the Court, for distribution to investors, \$208,000 in proceeds from three previously frozen bank accounts. FAMILY LIFE INSURANCE COMPANY

An order has been issued to Family Life Insurance Company, et al., approving substitutions of certain securities issued by an open-end management investment company, and held by a separate account of Family Life, in order to preserve the current tax status of certain variable annuity contracts funded by the separate account, in light of temporary regulations issued recently by the Internal Revenue Service. HOLDING COMPANY ACT RELEASES

NATIONAL FUEL GAS COMPANY

A notice has been issued giving interested persons until January 5, 1987 to request a hearing on a proposal by National Fuel Gas Company, a registered holding company, and its subsidiary, Seneca Resources Corporation, whereby National will issue and sell up to one million shares of common stock, and make capital contributions to Seneca up to the amount of the proceeds through December 31, 1988; and for National to amend its Restated Certificate of Incorporation to increase the number of authorized shares of its common stock from 20 million shares to 100 million shares and to delete all references to the 9.20% Series of Preferred Stock, as that Preferred Stock has been redeemed. In addition, National has been authorized to solicit proxies for voting on the proposal to increase the number of of authorized shares at the 1987 Annual Meeting, to be held on February 19, 1987.
