PROSPECTUS DELIVERY DURING QUIET PERIOD

The Commission is publishing for comment alternative amendments to Rule 174 under the Securities Act of 1933 which would reduce or eliminate under certain circumstances the 40 or 90 day delivery period during which dealers must deliver a prospectus in aftermarket transactions in registered securities following a public offering.

# **CIVIL PROCEEDINGS**

#### INTERNATIONAL CAPITAL CORPORATION NAMED IN COMPLAINT

The Commission filed an injunctive action on December 16 in the U.S. District Court for the District of Columbia against International Capital Corporation (ICC) of Denver, Colorado. ICC registered 20,000,000 shares of its common stock in a blind pool offering in 1985. The complaint alleges violations of the reporting provisions of the securities laws and seeks a judgment of permanent injunction and other equitable relief.

The Commission alleges that ICC, as part of a continuing course of violative conduct, failed to file its Annual Report on Form 10-K for its fiscal year ended January 31, 1986, and its Quarterly Reports on Form 10-Q for its fiscal quarters ended October 31, 1985, April 30, and July 31, 1986. The Commission further alleges that ICC failed to file Notifications of Late Filing and failed to file a complete and accurate report on Form 8-K including an audited historical financial statement of Film Productions, Inc. (FPI) and a pro forma financial statement reflecting ICC's acquisition of FPI. The Commission seeks a Court order compelling ICC to file its delinquent Annual and Quarterly Reports and a complete and accurate Current Report and enjoining it from further violations of the reporting provisions of the securities laws. ## **INVESTMENT COMPANY ACT RELEASES**

### INTEGRATED RESOURCES LIFE INSURANCE COMPANY

#### THE CONNECTICUT LIGHT AND POWER COMPANY

Yan All An order has been issued authorizing The Connecticut Light and Power Company (CL&P), subsidiary of Northeast Utilities, to acquire a 0.3125% ownership interest in a nuclear generating unit, Millstone Unit No. 3 (Millstone 3), from the City of Burlington, Vermont, Electric Light Department (Burlington). CL&P, Burlington, and other New England utility companies are tenants with dommon of Millstone 3, which they own in designated percentage shares. As consideration for the transfer, Burlington would be released from all liability to CL&P resulting from the payment by CL&P's service company affiliate and agent, Northeast Utilities Service Company, of Burlington's proportionate share of the costs of all capital items for Millstone 3, except nuclear fuel, from February 1982, the date of commercial operation, through April 23, 1986.
