## ADMINISTRATIVE PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST CITIWIDE SECURITIES CORP. AND HERBERT CANNON

The Commission ordered public administrative proceedings under the Securities Exchange Act of 1934 against Citiwide Securities Corp. (Registrant), a registered broker-dealer located in New York, New York, and its president, Herbert Cannon.

The Order for Public Proceedings alleges that from about April 30 to about May 23, 1985, while it transacted business with its public customers, Registrant, aided and abetted by Cannon, failed to: (1) maintain the minimum net capital required; (2) maintain net capital equal to 120 percent of the minimum dollar amount required after giving effect to a \$188,300 equity capital withdrawal; (3) prepare an accurate net capital computation; (4) file accurate reports with the National Association of Securities Dealers, Inc.; (5) give timely telegraphic notice of its failure to maintain the required amount of net capital; and (6) timely file a Part IIA Financial and Operational Combined Uniform Single Report for the month ending April 30, 1985.

A hearing will be scheduled to determine whether the allegations are true and, if so, to decide what, if any, remedial action is appropriate. (Rel. 34-23885)

M. RIMSON & CO., INC. AND MOSHE RIMSON SUSPENDED FROM UNDERWRITING ACTIVITIES

> The Commission instituted public administrative proceedings and imposed sanctions against M. Rimson & Co., Inc. (Rimson & Co.), a registered broker-dealer, and Moshe Rimson (Rimson), a registered representative and the president of Rimson & Co., for violating the antifraud provisions of the securities laws. Simultaneously, Rimson & Co. and Rimson submitted an Offer of Settlement which the Commission accepted.

In its Order, the Commission made findings to which Rimson & Co. and Rimson consented without admitting or denying. The Commission found that Rimson & Co. and Rimson, during 1983: (1) participated in the distribution of a false and misleading prospectus in connection with a public offering by North Atlantic Airlines, Inc.; (2) failed to conduct an independent investigation of North Atlantic despite being the co-underwriter of the offering; and (3) failed to price the offering and conduct its own due diligence investigation as it had represented it would as a Qualified Independent Underwriter of the offering.

The Commission imposed sanctions suspending Rimson & Co. and Rimson from acting as an underwriter for four months, and requiring Rimson & Co. to comply with its undertaking to retain independent underwriters' counsel. Rimson & Co. and Rimson also consented to a permanent injunction. (Rel. 34-23887)

# CIVIL PROCEEDINGS

PERMANENT INJUNCTION ENTERED AGAINST M. RIMSON & CO., INC. AND MOSHE RIMSON IN NORTH ATLANTIC AIRLINES CASE

The New York Regional Office announced that on December 5 U.S. District Judge Kevin Thomas Duffy, Southern District of New York, entered a Final Judgment of Permanent Injunction against M. Rimson & Co., Inc. (Rimson & Co.), a registered broker-dealer, and Moshe Rimson (Rimson), its president and a registered representative. Rimson & Co. and Rimson, without admitting or denying the allegations of the complaint, consented to the Final Judgment which permanently enjoins them from violating the antifraud provisions of the securities laws.

In its complaint, the Commission alleged that Rimson & Co. and Rimson, while acting as a co-underwriter of a \$2 million public offering of securities of North Atlantic Airlines, Inc. during 1983, distributed and caused to be distributed a prospectus that contained false and misleading information. In addition, it was alleged that Rimson & Co., contrary to express representations in the prospectus that it was acting as a Qualified Independent Underwriter under Schedule E of the By-Laws of the NASD, failed to fulfill its responsibilities as a Qualified Independent Underwriter of the offering. (SEC v. North Atlantic Airlines, Inc., et al., USDC SDNY, 86 Civ. 442). (LR-11306)

#### ACCOUNTANT WARREN ESSNER ENJOINED IN DRYSDALE MATTER

The Commission announced that on December 19 a Final Consent Judgment of Permanent Injunction was entered in the U.S. District Court for the Southern District of New York against Warren Essner, formerly a partner of Arthur Andersen & Co. In settling the action filed in July 1983, Essner neither admitted nor denied the Commission's allegations concerning his role in the establishment of Drysdale Government Securities, Inc., a government securities dealer which failed in May 1982.

Essner has been enjoined from violating or aiding and abetting violations of the general antifraud provisions of the securities laws.

This settlement concludes the action in which three former Drysdale officials also consented to permanent injunctions, and they and another pled guilty to various crimes and were barred from the securities industry. (SEC v. Drysdale Securities Corp., et al., USDC SDNY, 83 Civ. 5599, RWS). (LR-11318)

SALOMON BROTHERS MORTGAGE SECURITIES III, INC.

Jurisdiction has been reserved with regard to the issuance of five million additional shares of common stock to the Dividend Plan and one million shares of common stock to the Employee Savings Plan for The Southern Company. MIDDLE SOUTH UTILITIES, INC.

# **ACQUISITIONS OF SECURITIES**

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
