RULES AND RELATED MATTERS

CORRECTION TO RELEASE ADOPTING FINAL RULES

A technical correction is being made to the release adopting amendments to Form N-1A, the registration form used by open-end management investment companies under the Investment Company Act of 1940 and the Securities Act of 1933, and related rules and forms that was published Monday, April 12, 1993 [58 FR 19050]. As the Commission stated in that release, performance information contained in periodic reports to shareholders is exempt from the currentness requirements of Rule 34b-1. The rule text setting forth this exemption was inadvertently omitted from the release. (Rel. 33-6993; IC-19412)

HOLDING COMPANY ACT RELEASES

TEXAS UTILITIES COMPANY

A notice has been issued giving interested persons until May 10, 1993 to request a hearing on an application filed by Texas Utilities Company (Texas Utilities), a public-utility holding company exempt from registration by order pursuant to Section 3(a)(1) of the Act, under Sections 3(a)(1), 9(a)(2) and 10 of the Act. Texas Utilities proposes to acquire all of the outstanding common shares of Southwestern Electric Service Company, a Texas electric utility company. Texas Utilities also requests an order of exemption under Section 3(a)(1) from all provisions of the Act, except Section 9(a)(2), following the proposed transactions. (Rel. 35-25797)

EASTERN UTILITIES ASSOCIATES, ET AL.

A notice has been issued giving interested persons until May 10, 1993 to request a hearing on a proposal by Eastern Utilities Associates (EUA), a registered holding company, and its wholly owned subsidiary company, EUA Cogenex Corporation (Cogenex) (collectively, Applicants) to finance Cogenex for the period ending December 31, 1995 in an amount not to exceed \$100 million. In connection with such financing, Applicants have received an exception from the competitive bidding requirements of Rule 50. (Rel. 35-25797)

ARKANSAS POWER & LIGHT COMPANY

A notice has been issued giving interested persons until May 10, 1993 to request a hearing on a proposal by Arkansas Power & Light Company (AP&L), an electric utility

subsidiary company Entergy Corporation, a registered holding company. AP&L proposes to enter into a Loan Agreement with Independence County, Arkansas (County) so that the County will issue up to \$45 million aggregate principal amount of one or more new series of tax-exempt revenue bonds (Tax-Exempt Bonds) to be used to refinance \$45 million principal amount of County 11 1/8% Pollution Control Revenue Bonds, 1983 Series. In addition, AP&L proposes to guarantee payment on the Tax-Exempt Bonds by entering into a Letter of Credit and Reimbursement Agreement for the issuance of a letter of credit, providing an insurance policy on the Tax-Exempt Bonds and/or issuing collateral bonds. UNLISTED TRADING PRIVILEGES SOUGHT

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-93-16) to amend the Rules of Practice and Procedure for the Small Order Execution System and would provide for operational modifications to the Small Order Execution System. (Rel. 34-32143)

The New York Stock Exchange filed a proposed rule change (SR-NYSE-93-10) to amend NYSE Rule 345 to establish a new category of limited registration for floor members engaged in public business with professional customers and to adopt the Content Outline for the Examination Module for Floor Members Engaged in Public Business with Professional Customers (Series 7A). Publication of the proposal is expected in the Federal Register during the week of April 19. (Rel. 34-32158)

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-92-41) that would amend Section 8, Part VI of Schedule D of the NASD By-Laws. The proposed rule change would provide a means to assist market makers in complying with Rule 10b-6 and 10b-6A under the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of April 19. (Rel. 34-32160)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the New York Stock Exchange (SR-NYSE-93-06) to increase its one-time annual licensing and support fees for P.C. software products and to establish prices for multi-system users and for system upgrades for P.C. Fallback has become effective under Section 19(b)(3)A) of the Securities Exchange Act of 1934. (Rel. 34-32161)

TEMPORARY ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-93-21), which the Commission approved on an accelerated basis for 60 days from the date of publication in the Federal Register in order to solicit comment on the proposed amendments. The purpose of the rule is to amend Schedule D of the NASD By-Laws in order to provide a procedure for notification to Nasdaq Operations to provide a procedure for notification to Nasdaq Operations to identify the quotations of market makers participating as passive in accordance with Rule 10b-6A under the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of April 19. (Rel. 34-32159)
