ADMINISTRATIVE PROCEEDINGS

THREE FORMER STUART-JAMES CO., INC. EMPLOYEES BARRED AND ORDERED TO CEASE AND DESIST VIOLATIONS

Chief Administrative Law Judge Warren E. Blair issued an initial decision barring Martin Herer Engelman of Escondido, California, Peter Paul Kim of San Diego, California, and David Lawrence Isen of San Diego, California from association with any broker or dealer, and ordering each of them to cease and desist from committing or causing a violation and from committing or causing any future violation of Section 17(a) of the Securities Act of 1933 or of Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder.

Judge Blair found that each of the three had willfully violated the antifraud provisions of the Securities Act of 1933 and of the Securities Exchange Act of 1934 in the purchase, offer and sale of low-priced highly speculative securities during their employment in the San Diego branch office of Stuart-James Co., Inc., a now defunct broker-dealer. INVESTMENT COMPANY ACT RELEASES

LINCOLN NATIONAL CONVERTIBLE SECURITIES FUND, INC., ET AL.

A notice has been issued giving interested persons until November 30 to request a hearing on an application filed by Lincoln National Convertible Securities Fund, Inc., et al. Applicants seek a conditional order under Sections 6(c) and 17(d) and Rule 17d-1 permitting Lincoln National Convertible Securities Fund, Inc. and Lincoln National Income Fund, Inc. (Funds) to participate in certain joint transactions with each other and with certain affiliated persons of the Funds; and the receipt of certain fees and expenses by the Funds' investment adviser in connection with such transactions. COLLECTIVE INVESTMENT TRUST FOR CITIBANK IRA'S

A notice has been issued giving interested persons until November 29 to request a hearing on an application filed by Collective Investment Trust for Citibank IRA's for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. UNITED FINANCIAL GROUP, INC.

A notice has been issued giving interested persons until November 30 to request a hearing on an application filed by United Financial Group, Inc. for an order under Section 6(c) and 6(e) of the Investment Company Act that would conditionally exempt applicant from all provisions of the Act until December 30, 1994. The requested relief would continue an exemption originally granted until December 30, 1990, extended by amended orders until December 30, 1991, December 30, 1992 and December 30, 1993. (Rel. HOLDING COMPANY ACT RELEASES

ALLEGHENY POWER SYSTEM, INC., ET AL.

A supplemental order has been issued authorizing a proposal by Allegheny Power System, Inc. (Allegheny), a registered public utility holding company; three public utility subsidiary companies of Allegheny -- Monongahela Power Company (Monongahela), Potomac Edison Company (Potomac Edison), and West Penn Power Company (West Penn); Allegheny Generating Company (Allegheny Generating), an electric public utility subsidiary of Monongahela, Potomac Edison, and West Penn; and Allegheny Power Service Corporation (Allegheny Service), a service company subsidiary of Allegheny. Under the proposal,

the Allegheny system would continue its short-term financing program from December 31, 1993 through December 31, 1995. The short-term financing program would include bank notes to be issued under lines of credit, and commercial paper, for Allegheny, Monongahela, Potomac Edison, and West Penn; commercial paper and promissory notes under a revolving credit agreement for Allegheny Generating; and a money pool among Allegheny, Monongahela, Potomac Edison, West Penn, Allegheny Generating, and Allegheny Service. EUA ENERGY INVESTMENT CORPORATION

A notice has been issued giving interested persons until November 29 to request a hearing on a proposal by EUA Energy Investment Corporation (EEIC), a wholly owned subsidiary of Eastern Utilities Associates, a registered holding company. EEIC proposes through December 31, 1996 to transfer an energy-related computer system to a joint venture limited partnership known as TransCapacity Limited Partnership (Partnership). In addition, EEIC proposes to make capital contributions of up to \$1 million and provide financing up to \$2 million to the Partnership in order to allow the Partnership to develop the business which will employ such system. MISSISSIPPI POWER & LIGHT COMPANY

An order has been issued authorizing a proposal by Mississippi Power & Light Company (MP&L), an electric public-utility subsidiary of Entergy Corporation, a registered holding company. By authority of prior Commission orders, MP&L was authorized, subject to certain reservations of jurisdiction, through December 31, 1993 to acquire certain of its outstanding securities (Acquisition Program); issue and sell up to \$25 million of tax-exempt bonds (Tax-Exempt Bonds) and certain amounts of its general and refunding mortgage bonds (Bonds) and its preferred stock (Preferred); and amend its Restated Articles of Incorporation, as amended (Charter), to establish a new class MP&L now proposes to increase the amount of Bonds it is of preferred stock. authorized to issue and sell to \$300 million; increase the aggregate par value of the Preferred it is authorized to issue and sell to \$50 million; amend its Charter to increase the number of authorized shares of its Preferred, \$100 par value, by 1.5 million shares; extend the date through which its Bonds, Preferred and Tax-Exempt Bonds may be issued, the Acquisition Program may be effected and the Charter may be amended from December 31, 1993 to December 31, 1995, in each case under the same terms and conditions as currently apply; and issue and sell up to \$65 million aggregate principal amount of a new series of Bonds. SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The New York Stock Exchange filed a proposed rule change (SR-NYSE-93-35) to add the failure by members and member organizations to adhere to the procedures for entry and cancellation of market-on-close orders on expiration days to the list of Exchange rule violations and fines applicable thereto pursuant to Rule 476A. Publication of the proposal is expected in the <u>Federal Register</u> during the week of November 8. (Rel. 34-33161)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by <u>The Options Clearing Corporation</u> (SR-OCC-93-08) to accommodate the clearance and settlement of a version of Quarterly Index Expiration Options being offered for trading on the New York Stock Exchange. (Rel. 34-33158)
