(1)	Use <u>CPOE</u> for medication orders directly entered by any licensed healthcare professional who can enter orders into the medical record per state, local and professional guidelines.	AVAILABLE	
(2)	Implement drug-drug and drug-allergy interaction checks.	AVAILABLE	
(3)	Maintain an up-to-date problem list of current and active diagnoses.	AVAILABLE	
(4)	Generate and transmit permissible prescriptions electronically (eRx).	AVAILABLE	
(5)	Maintain active medication list.	AVAILABLE	
(6)	Maintain active medication allergy list.	AVAILABLE	
(7)	Record all of the following demographics: (A) Preferred language. (B) Gender. (C) Race. (D) Ethnicity. (E) Date of birth.	AVAILABLE	
(8)	Record and chart changes in the following vital signs: (A) Height. (B) Weight. (C) Blood pressure. (D) Calculate and display body mass index (BMI). (E) Plot and display growth charts for children 2–20 years, including BMI.	AVAILABLE	
(9)	Record smoking status for patients 13 years old or older.	AVAILABLE	
(10)	Report ambulatory <u>clinical quality measures</u> to CMS or, in the case of Medicaid EPs, the States.	AVAILABLE	
(11)	Implement one <u>clinical decision support rule</u> relevant to specialty or high clinical priority along with the ability to track compliance with that rule.	AVAILABLE	
(12)	Provide patients with an electronic copy of their health information (including diagnostics test results, problem list, medication lists, medication allergies) upon request.	AVAILABLE	
(13)	Provide clinical summaries for patients for each office visit.	AVAILABLE

(14)	Capability to <u>exchange key clinical information</u> (for example, problem list, medication list, allergies, and diagnostic test results), among providers of care and patient authorized entities electronically.	AVAILABLE	
(15)	<u>Protect electronic health information</u> created or maintained by the certified EHR technology through the implementation of appropriate technical capabilities.	AVAILABLE	

Eligible Professional Menu Objectives			
(1)	Implement drug formulary checks.	AVAILABLE	
(2)	Incorporate clinical lab-test results into EHR as structured data.	AVAILABLE	
(3)	Generate <u>lists of patients</u> by specific conditions to use for quality improvement, reduction of disparities, research, or outreach.	AVAILABLE	
(4)	Send <u>patient reminders</u> per patient preference for preventive/follow-up care.	AVAILABLE	
(5)	<u>Provide patients with timely electronic access</u> to their health information (including lab results, problem list, medication lists, and allergies) within 4 business days of the information being available to the EP.	AVAILABLE	
(6)	Use certified EHR technology to identify <u>patient-specific education resources</u> and provide those resources to the patient if appropriate.	AVAILABLE	
(7)	The EP who receives a patient from another setting of care or provider of care or believes an encounter is relevant should perform <u>medication reconciliation</u> .	AVAILABLE	
(8)	The EP who transitions their patient to another setting of care or provider of care or refers their patient to another provider of care should provide summary care record for each transition of care or referral.	AVAILABLE	
(9)	Capability to <u>submit electronic data to immunization registries</u> or immunization information systems and actual submission according to applicable law and practice.	AVAILABLE
