October 1, 2012 through September 30, 2013.

Monday, October 1, 2012.

### **RESTRAINT LEVEL:**

(Aggregate quantity allocations)

Apparel articles knit to shape

970,000,000 square meter equivalents

(Other than socks)

T-shirts 12,000,000 dozen.

Once the in-quota allocation is filled, goods will be allowed to enter at Normal Trade Relations rate or General rate of duty as noted in the HTSUS.

Merchandise classified in Chapter 62 (other than Heading 6212) is not subject to the tariff rate quotas provided for under HTSUS 98201112 and 98201109; therefore, it should not be charged against the quota restraint levels.
