

**Changes in LC-PCC Policy Statements in the October 2012 release of the RDA Toolkit**

With the October 2012 release of the *RDA Toolkit*, the title of the *Library of Congress Policy Statements (LCPS)* will be changed to reflect the shared nature of the policy statements with the Program for Cooperative Cataloging. The new title will be: *Library of Congress-Program for Cooperative Cataloging Policy Statements (LC-PCC PS)*. As with previous updates, the October release will continue the effort to label existing policy statements with “PCC Practice” statements where applicable; this will be an ongoing task until all statements are clearly labeled.
