

Imports and Exports of Fishery Products Annual Summary, 2001

IMPORTS. U.S. imports of edible fishery products in 2001 were valued at \$9.9 billion, \$189.6 million less than in 2000. The quantity of edible imports was 1,860,652 metric tons, a 56,133 ton increase from the quantity imported in 2000.

The quantity of shrimp imported in 2001 was 400,336 tons, 55,260 tons more than the quantity imported in 2000. Valued at \$3.6 billion, shrimp imports accounted for 37 percent of the value of total edible imports. Imports of salmon, including fillets, were 175,092 tons valued at \$818.2 million in 2001. Imports of fresh and frozen tuna were 183,621 tons, 18,326 tons less than imported in 2000. Imports of canned tuna were 132,542 tons, 9,419 tons less than in 2000. Imports of fresh and frozen fillets and steaks amounted to 360,848 tons, an increase of 27,585 tons from 2000. Regular and minced block imports were 66,534 tons, a decrease of 25,956 tons from 2000. Edible imports consisted: of 1,564,351 tons of fresh and frozen products valued at \$8.8 billion; 244,610 tons of canned products valued at \$774.2 million; 32,507 tons of cured products valued at \$150.1 million; 2,338 tons of caviar and roe products valued at \$43.2 million; and 16,846 tons of other products valued at \$64.8 million.

Imports of nonedible fishery products were valued at \$8.7 billion, \$276.7 million less than imported in 2000. Total value of edible and nonedible products was \$18.5 billion in 2001, \$466.3 million less than in 2000, when \$19.0 billion of fishery products were imported.

EXPORTS. U.S. exports of edible fishery products of domestic origin were 1,139,744 tons valued at \$3.1 billion, compared with 948,025 tons at \$2.8 billion exported in 2000.

Fresh and frozen items were 979,216 tons valued at \$2.2 billion, an increase of 172,435 tons and \$109.9 million compared with 2000. Fresh and frozen exports consisted principally of 93,932 tons of salmon valued at \$296.2 million, 26,662 tons of lobster (*Homarus spp.*) valued at \$253.9 million, and 181,279 tons of surimi valued at \$297.6 million. Canned items were 81,699 tons valued at \$235.4 million. Salmon was the major canned item exported, with 49,405 tons valued at \$166.4 million. Cured items were 10,013 tons valued at \$29.7 million. Caviar and roe exports were 47,747 tons valued at \$548.5 million. Other edible products accounted for 21,069 tons valued at \$31.3 million.

Exports of nonedible products were valued at \$7.8 billion. Exports of fish meal amounted to 107,962 tons valued at \$67.6 million. The total value of edible and nonedible exports was \$10.8 billion, \$1.1 billion more than in 2000.

RE-EXPORTS. U.S. exports of edible fishery products of foreign origin were 23,714 tons valued at \$124.6 million, compared to 34,010 tons valued at \$147.2 million re-exported in 2000. Fresh and frozen items were 20,449 tons valued at \$95.3 million a decrease of 7,213 tons and \$28.1 million compared with 2000. Fresh and frozen shrimp was the principle product at 3,647 tons valued at \$32.8 million. Canned items accounted for 1,398 tons valued at \$4.6 million. Cured products were 325 tons valued at \$1.5 million. Caviar and roe re-exports were 1,009 tons valued at \$18.4 million. Other edible products were 533 tons valued at \$4.7 million.

Re-exports of nonedible fishery products were valued at \$869.8 million. Fish oils accounted for 457 tons valued at \$715 thousand. The total value of edible and nonedible re-exports was \$994.4 million, \$47.9 million less than in 2000.

NOTES. Unless otherwise noted, the information presented is based on Bureau of the Census data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs Service, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
