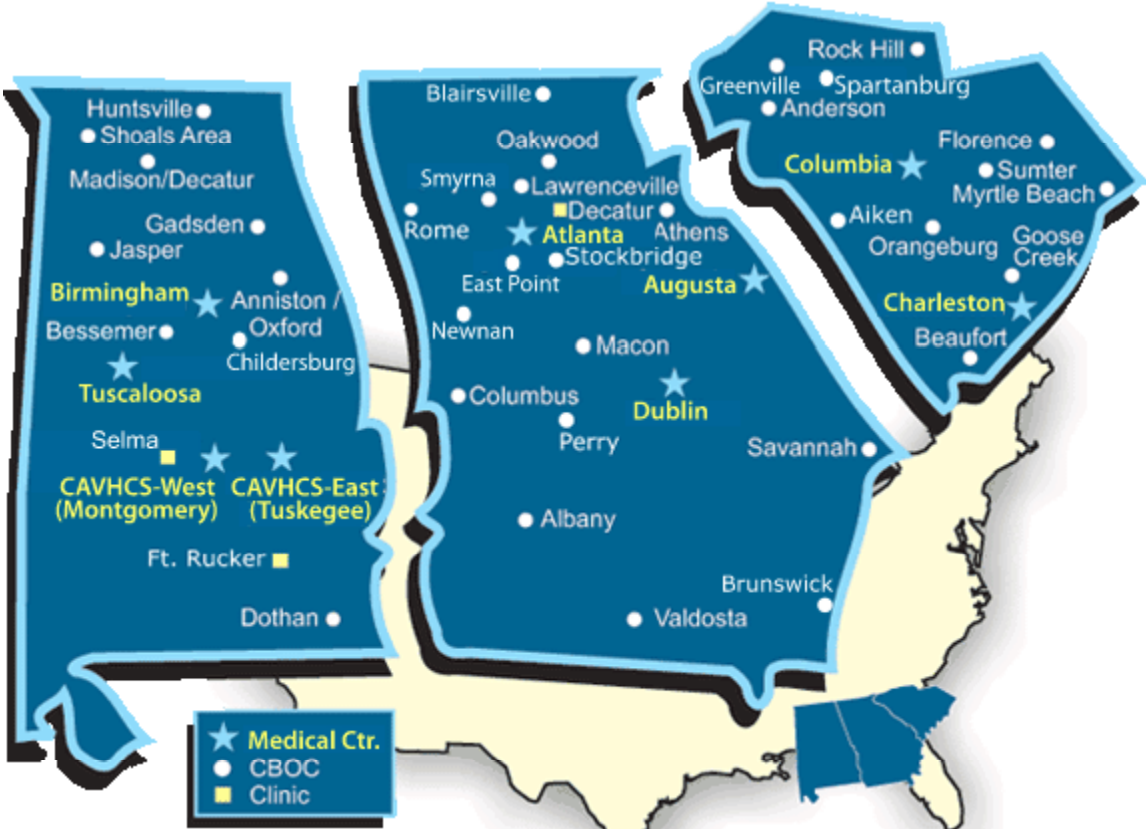

VISN 7 provides a comprehensive range of primary and tertiary care services to veterans in rural and metropolitan markets in Alabama, Georgia and South Carolina.

VISN 7 is experiencing tremendous growth with an influx of veterans retiring to the area, and even more predicted in the next ten years. To meet the demands of this growth, VISN 7 has shifted resources from hospital based services to community and home based services.

VISN 7 delivers state of the art health care services through eight Medical Centers, 27 Community Based Outpatient Clinics, seven Nursing Home Care Units, three Domicillary facilities and six Vet Centers.
