- 1. In accordance with the Veterans Administration Acquisition Regulation (VAAR) 801.404, Class Deviations, your approval is requested to deviate from VAAR 808.001, Priorities for Use of Government Supply Sources. Specifically, a class deviation is requested for (a) (6) VA decentralized contracts, (7) Mandatory Federal Supply Schedule contracts, and (8) Optional use Federal Supply Schedule contracts.
- 2. This deviation would provide the best opportunity to achieve optimal pricing and other terms for VA and other Government agencies.
- 3. The contract hierarchy, as listed in the Procurement Reform Task Force Report, will be as follows.
 - a. "Tier One
 - National committed use contracts.
 - VA Federal Supply Schedule (FSS) Groups 65 and 66 for health care supplies in the following order of priority.
 - Nationally awarded Blanket Purchase Agreements issued against FSS contracts (by the NAC).
 - Multi-VISN, VISN, or locally awarded BPAs issued against FSS contracts.
 - FSS purchases."
 - b. "Tier Two
 - VISN or regionally awarded contracts for items without national or FSS contracts.
 - Locally awarded contracts for items without national or FSS contracts."

 - Open-market purchases."

Subj: Class Deviation from VAAR 808.001, Priorities for Use of Government Supply Sources

To: Deputy Secretary (001)

- 1. In accordance with the VA Acquisition Regulation (VAAR) 801.404, Class Deviations, the Deputy Assistant Secretary for Acquisition and Materiel Management has concluded that there is a need for a class deviation to VAAR 808.001, Priorities for Use of Government Supply Sources. The need is based on the information provided in the attached memorandum. I support that conclusion and recommend your approval of a class deviation.
- 2. Approval of this deviation would implement Procurement Reform Task Force recommendation 1.1.1, Establish a contract hierarchy which mandates VA use of VA Federal Supply Schedules (FSS) Groups 65 and 66. This class deviation will mandate the use of VA negotiated contracts for FSS Group 65, Medical, dental and veterinary equipment and supplies and Group 66, Instruments and laboratory equipment. The use of VA FSS will allow the Department to leverage its aggregate buying power of health care items and improve VA's ability to effectively manage acquisition program resources.
