The Open Government Plan process illuminated the need for an advanced consolidated data infrastructure at VA. This recognition has lead to high level and senior leaders at VA forming a working group to tackle the questions: where is our data, who owns it and how are we going to package and distribute the data in a transparent manner. The result of the working group will be a plan that will, in part, demarcate education materials and data for free re-use.
