## 2012 - 2013 Service & Accreditation Crosswalk

The Ohio Rehabilitation Services Commission (RSC) and the Commission on Accreditation of Rehabilitation Facilities (CARF) have collaborated in developing this crosswalk that correlates services that VR purchases when a Community Rehabilitation Programs (CRP) subcontracts a service. If a Sub-Contractor wants to provide a VR service, the primary CRP (the agency that is accredited) must be accredited in the area located in the right column of the service. (NOTE: CRPs that provide all services with their own Staff only need to be accredited in one of the areas of accreditation listed below, i.e. EDS, EPS, CES, CVE, etc.)

The crosswalk provides a reference to the Section and page # where additional information can be found in the CARF Manuals. (Page numbers are in reference to the 2012 Employment & Community Services Manual, unless otherwise noted.)

The crosswalk is reviewed by CARF and RSC annually to ensure that it reflects the most recent and accurate data. RSC and CARF reserve the right to make changes to the crosswalk as needed to ensure the quality of services provided to Ohioan's with disabilities.
