What payment information do I need to register?

When registering for the GPO Online Paper Store the most common method of payment is by government purchase or (IMPAC) credit card. If you do not wish to use a credit card, you can set up your account using a GPO IPAC billing account or a GPO Deposit account. If you have questions on these billing methods, please contact your appropriate GPO National Account Manager (NAM) for your agency.

How do I register with a credit card?

Click the link to register directly online.

No paper forms are needed. Go to

form and click Submit. Your information will
be verified within 3 business days, and your
username and password will be emailed to
you at the address you provided.

What is a BAC?

A BAC is a Billing Address Code, which is an agency reference code assigned by GPO. GPO uses this 6-digit number to charge your IPAC (Intra-governmental Payment and Collection System) or GPO Deposit Account. If you don't know your BAC, please contact your GPO National Account Manager (NAM) or complete the Inquiry of Interest form.

What if I don't have a BAC or don't know it?

If you don't know your GPO BAC, please contact your **GPO National Account Manager** (NAM) or complete the **Inquiry of Interest** form.

Will the prices ever change on this contract?

Yes. The paper industry is very volatile and many of the prices are directly impacted by the cost of fuel and recycled materials. The prices on this contract can change as the industry fluctuates. Typically, GPO informs all active customers with at least 14 days notice of any price change and price changes can not occur within 90 days of each other.

What is a Requisition Number?

A requisition is a number assigned by your agency for internal tracking of obligated funds. The format is x-xxxxx, where the first number represents the current fiscal year (for example, for fiscal year 2011 the requisition format would be 1-xxxxx). This number changes with each fiscal year and must be updated by your agency. All Online Paper Store transactions will be charged under the requisition number you provide. Your requisition number can be up to 18 total characters. The first 5 characters after the hyphen must be numeric.

If you don't know what requisition number to use, please contact the Printing Officer at your agency or your **GPO National Account Manager** (NAM). You may also complete the **Inquiry of Interest** form.

How do I register with a BAC?

Click the link for **Register**. Fill out the online form and click **Submit**. A PDF of **Form 2747** will be emailed to you. Print this form and sign it. Fax the form to **202.512.1569**. Your information will be verified by GPO, and your username and password will be emailed to you at the address you provided within 3 days of verification.

Why do I have to send in Form 2747?

GPO must verify that you are authorized to obligate funds for your Billing Address Code (BAC). This is done by signature verification. By signing this form, you authorize the funding for orders placed at the Online Paper Store.

What if my agency is not listed on the Registration Menu?

Select Other from the Agency Name dropdown list on the online registration form. Fill in the name of your agency, be sure to type the full and correct name, and complete the rest of the form. You will be contacted if more information is needed.

I am a contractor employed by the Federal government. Can I register?

If you are a contractor performing functions on behalf of a Federal government agency, you will need to use a BAC and requisition number assigned by the agency for which you are working for. If you don't know your BAC, please contact your GPO National Account Manager (NAM).

How do I renew my requisition for the new fiscal year?

You can send in your renewal open requisition for the Online Paper Store at the same time that other open requisitions are requested by GPO. The open requisition may be sent to:

How can I assign a Line of Accounting (LOA) or Appropriation Chargeable reference to an order?

When you check out at the Online Paper Store, an optional field is available for assigning a Line of Accounting, Appropriation Chargeable, or other agency reference to a particular order. **This reference will not appear on your bill**, but may be referenced by GPO when researching billing inquiries.

What products are available for purchase at the Online Paper Store?

The Online Paper Store offers the following xerographic paper products, all of which are 20 lb and contain a minimum of 30% Post Consumer Waste (PCW) recycled paper:

- 8-1/2 x 11" white
- 8-1/2 x 11" white 3-hole punched
- 8-1/2 x 14" white
- 11 x 17" white
- 8-1/2 x 11" colored paper, available in blue, buff, green, pink, salmon, and yellow.

GPO also offers papers that contain a higher percentage of PCW recycled paper. These papers are:

- 8-1/2 x 11" white, 20lb, 50% PCW recycled paper
- 8-1/2 x 11" white, 20lb, 100% PCW recycled paper

In addition, GPO offers a white, 24lb stock in 8-1/2 x 11" 30% PCW recycled paper.

As of 2012, GPO offers two stocks which contain no postconsumer fiber. These papers are:

- 8-1/2 x 11" white, 20lb
- 8-1/2 x 11" white, 24lb

What is the smallest quantity I can order?

The minimum order for all products through the GPO Online Paper Store is one carton.

Can I mix colors in my order?

You must order at least one carton of each color

Are there any taxes or additional charges that will appear on my bill?

No. The price you see in the Online Paper Store catalog is the price you will pay.

Is there an extra charge for delivery?

Standard Delivery is included in the price of the paper; however, delivery locations must be able to accommodate a truck height of a minimum of 12' 6". Any orders that require a smaller truck will be subject to an additional delivery charge. Orders that require delivery to multiple floors shall incur an additional charge of \$250.

How long will it take to get my order?

The Online Paper Store offers same-day and next-day delivery in major cities. Most other metropolitan areas receive delivery within 48 hours.

What if I have a problem with my order?

What if I have multiple shipping addresses?

just like a new startup). You can provide the shipping addresses upfront and Unisource will proactively setup the accounts.

What if I have multiple BACs?

Currently, each account can only contain one BAC and requisition number. If you have multiple BACs you will have to set up multiple Online Paper Store accounts to ensure separation of billings. Contact your GPO National Account Manager (NAM) if you have questions.

When I log on to the Online Paper Store the availability of the product I want to order says "0". Can I still order this product?

Yes. Keep it in your cart and place your order.

A Unisource representative will contact you about delivery.

What is my payment method?

If you use a GPO BAC, your payment method will display as "**Purchase Order**".

If you use a government purchase or (IMPAC) credit card, your payment method will display as "Credit Card".

What is my delivery method?

For standard orders that include the shipping prices as outlined in the Online Paper Store, customers should choose "**Standard Delivery**".
