Instructions for Filing an Initial Notice

Use This Form If:

- You are an importer or manufacturer of a digital audio recording device or a digital audio recording medium, and
- You have distributed the device or medium in the United States on or after October 28, 1992.

When to File

- An initial notice must be recorded in the Copyright Office within 45 days after the commencement of the first distribution in the United States of such devices or media.
- An initial notice must be recorded in the Copyright Office within 45 days after the commencement of the first distribution in the United States of a new product category or product utilizing new technology.
- The notice must be forwarded on the form provided by the Copyright Office to Copyright Office GC/I&R, DART Initial Notice, PO Box 70400, Washington, DC 20024-0400.

Space A

Line 1 • Give the full legal name of the importer or manufacturer of the digital audio recording device or digital recording medium. If the importer or manufacturer is a partnership, give the name of the partnership followed by the name of at least one individual partner. If the owner is a subsidiary of another corporation, give the full corporate title of the subsidiary, not that of the parent corporation.

Line 2 • Provide the current mailing address of the importer or manufacturer listed in line 1.

Space B

Line 1 • List the business name used by the importer or manufacturer if different from space A, line 1.

Line 2 • Give the mailing address if different from the mailing address in space A, line 2.

Line 3 • List any trade names, trademarks, or like indicia of origin that the manufacturer uses or intends to use in the future.

Space C

Provide the product category (e.g., portable personal recorder, boom box, automobile recorder), technology utilized (e.g., DAT, DCC), and the date of distribution for each product.

Space D

The notice must be signed in accordance with Copyright Office regulations. A photocopied or stamped signature is not acceptable.
