Provenance

The papers of the Preston, Campbell, and Floyd families of southwestern Virginia were obtained by the Library of Congress through purchase, 1930, and by gift from various sources, 1931-1955.

Processing History

The collection was processed prior to 1955 and partially rehoused in 2007. A finding aid was created in 2010.

Copyright Status

The status of copyright in the unpublished writings of the Campbell, Preston, and Floyd families is governed by the Copyright Law of the United States (Title 17, U.S.C.).

Access and Restrictions

The papers of the Campbell, Preston, and Floyd families are open to research. Researchers are advised to contact the Manuscript Reading Room prior to visiting. Many collections are stored offsite and advance notice is needed to retrieve these items for research use.

Microfilm

A microfilm edition of these papers is available on seven reels. Consult reference staff in the Manuscript Division concerning availability for purchase or interlibrary loan. To promote preservation of the originals, researchers are required to consult the microfilm edition.

Scope and Content Note

The papers of the Campbell-Preston-Floyd families span the years 1741-1931 and consists of correspondence, account books, survey books, memoranda, bills, receipts, and other papers pertaining to members of the Campbell, Preston, and Floyd families of southwestern Virginia.

The collection is arranged in chronological and miscellany files, with the latter organized by type of material. Oversize items housed at the end of the collection were filmed in the their original location.
