(C) by inserting after subsection (b) the following:

The Capitol Police Board, when in its judgment the public interest so requires, may exempt such a member from automatic separation under this subsection until that member becomes 60 years of age. The Board shall notify the member in writing of the date of separation at least 60 days before that date. Action to separate the member is not effective, without the consent of the member, until the last day of the month in which the 60-day notice expires.

(2) Section 8415(d) of title 5, United States Code, is amended by striking "(a) or (b)" and inserting "(a), (b), or (c)".
