¶63.31 NOTICE REQUIREMENT—MOTION TO INSTRUCT CONFEREES—H.R. 3355

Mr. MCCOLLUM, pursuant to clause 1(c) of rule XXVIII, announced his intention to instruct the managers on the part of the House at the conference with the Senate on the disagreeing votes of the two Houses on the House amendment to the Senate amendment to the bill (H.R. 3355) to amend the Omnibus Crime Control and Safe Streets Act of 1968 to allow grants to increase police presence, to expand and improve cooperative efforts between law enforcement agencies and members of the community to address crime and disorder problems, and otherwise to enhance public safety, be instructed not to agree to title IX, relating to racially discriminatory sentencing, of the House amendment or to any similar provision.

H.R. 4205. An Act to amend title 11, D.C. Code, to clarify that blind individuals are eligible to serve as jurors in the Superior Court of the District of Columbia.
