

In addition, Music Reports is an authorized “common agent” for various copyright owners of musical works including, but not limited to Belmondo Music, pursuant to 17 U.S.C. § 115(c)(3)(B). Music Reports wishes to fully participate in this proceeding including, without limitation, with respect to ensuring the transparent and efficient functioning of the license administration and royalty payment processes under the §115 statutory license, the terms and conditions of the §115 statutory license, any notice and recordkeeping requirements pertaining thereto, and any terms relating to the transparency and good governance of agents of copyright owners and of statutory licensees for the period covered by the proceeding.


