Abstract: Lawyer, army officer, United States representative from California, United States commissioner of Indian affairs, and governor of Kansas. Letterpress books containing correspondence relating to Denver's law practice in Washington, D.C., which was concerned with Choctaw Indian claims and land disputes in California and elsewhere in the West, and to his campaign for the Democratic presidential nomination, 1884.

Scope and Content Note

The papers of James William Denver (1817-1892) span the years 1868-1884 and consist of letterpress books containing correspondence relating to Denver's law practice in Washington, D.C. Denver and his law firm were concerned with Choctaw Indian claims and land disputes in California and elsewhere in the West. His papers also document his campaign for the Democratic presidential nomination in 1884. Four volumes contain Denver's correspondence; the fifth contains the correspondence of Sargeant Prentiss Nutt of Denver's law firm.
