Includes correspondence, printed matter, and other papers of Wright pertaining to the documents, as well as biographical material concerning Wright.

## Scope and Content Note

The papers of Irene Aloha Wright (1879-1972) span the years 1620-1977 and consist mainly of transcripts, copies, and translations of documents from Spanish archives. Included are positive and negative photocopies and typewritten transcripts of originals from the Archivo de Protocolos de Sevilla, Archivo General de Indias, and Instituto Hispano-Cubano de Historia de América, Seville, Spain. Also included is correspondence, printed matter, and other papers of Wright pertaining to the documents, with an addition containing biographical material concerning Wright. The material is in Spanish and English.
