UNANIMOUS CONSENT AGREEMENT William T. Lawrence (Cal. No. 627) G. Murray Snow (Cal. No. 628)

Ordered, That on Thursday, June 26, 2008, notwithstanding Rule XXII if applicable, at a time to be determined by the Majority Leader, following consultation with the Republican Leader, the Senate proceed to executive session to consider the nominations of William T. Lawrence, of Indiana, to be United States District Judge for the Southern District of Indiana and G. Murray Snow, of Arizona, to be United States District Judge for the District of Arizona; that they be debated concurrently for 1 hour, with the time equally divided and controlled between the Leaders or their designees; that upon the use or yielding back of time, the Senate proceed to vote on confirmation of the nominations in the order listed; with 2 minutes of debate time, equally divided and controlled in the usual form between the votes, and the second vote in the sequence be 10 minutes in duration; that upon confirmation, the motions to reconsider be laid upon the table en bloc; the President be immediately notified of the Senate's actions and the Senate then resume legislative session.
