Ordered, That on Thursday, June 8, 2006, if cloture is not invoked on H.R. 8 and S. 147, the Senate then proceed to executive session for consideration en bloc of the following nominations on the executive calendar; Noel Lawrence Hillman, to be U.S. District Judge for the District of New Jersey; Peter G. Sheridan, to be U.S. District Judge for the District of New Jersey; Thomas L. Ludington, to be U.S. District Judge for the Eastern District of Michigan, and Sean F. Cox, to be U.S. District Judge for the Eastern District of Michigan.

Ordered further, That there be 10 minutes of debate for each of the Senators from New Jersey (Mr. Lautenberg and Mr. Menendez), 10 minutes for the Senator from Michigan (Ms. Stabenow) and 10 minutes each for the Chairman and the Ranking Member of the Committee on the Judiciary; provided, that following the use or yielding back of time, the Senate proceed to consecutive votes on the nominations as listed but not prior to 2:00 p.m.

Ordered further, That following those votes the Senate proceed to the consideration of Susan C. Schwab, to be United States Trade Representative.

Ordered further, That there be 30 minutes of debate for the Senator from North Dakota (Mr. Dorgan), 15 minutes for the Senator from North Dakota (Mr. Conrad), 10 minutes for the Senator from Montana (Mr. Baucus), and 30 minutes for the Chairman of the Committee on Finance; provided further, that following the use or yielding back of time the Senate proceed to a vote on the confirmation of the nomination, with no intervening action or debate; provided further, that following the vote the President be immediately notified of all of the Senate's previous actions and the Senate resume legislative session.

Ordered, That relative to the cloture motion filed on the nomination of Richard Stickler, of West Virginia, to be Assistant Secretary of Labor for Mine Safety and Health, the mandatory quorum required under Rule XXII be waived.
