## UNANIMOUS CONSENT AGREEMENT

**Michael O. Leavitt (Cal. No. 405)**

*Ordered*, That the scheduled cloture vote at 5:30 p.m., Monday, October 27, 2003 be vitiated.

*Ordered further*, That at 9:30 a.m. on Tuesday, October 28, 2003, the Senate proceed to executive session to resume consideration of the Leavitt nomination and there be 60 minutes of debate equally divided between the Chairman of the Committee on the Judiciary and the Ranking Member or their designees, with 20 minutes of the Minority time under the control of Senator Lautenberg.

*Ordered further*, That following debate, the Senate proceed to a vote on the confirmation of the nomination, with no intervening action or debate; provided further, that following the vote, the President be immediately notified of the Senates action and the Senate then resume legislative session. (October 23, 24, 27, 2003)
