**FRANKLIN D. ROOSEVELT**

President Franklin D. Roosevelt vetoed 635 bills, of which 372 were regular vetoes and 263 were pocket vetoes. Nine were overridden (Item Nos. 1153, 1316, 1369, 1372, 1412, 1571, 1630, 1730, 1753). There were no vetoes in the second session of the Seventy-fifth Congress nor in the second session of the Seventy-sixth Congress.
