- 1. A law student, upon compliance with this Administrative Order, and under supervision of an attorney, may appear on behalf of any party.
  - 2. To appear, the student shall:
    - (a) be duly enrolled in a law school approved by the American Bar Association;
    - (b) be a participant in a clinical program approved by that law school;
    - (c) have successfully completed at least three semesters of legal studies;
    - (d) be certified by either the law school dean or authorized designee as qualified to provide the legal representation permitted by this Administrative Order. This certification may be withdrawn by the certifier at any time by mailing a notice to the Clerk of the Court, without notice or hearing and without the showing of cause;
    - (e) be introduced to the Court by an attorney admitted to practice before this Court;
    - (f) neither seek nor receive any compensation or remuneration of any kind from the client. This provision is not intended to affect the ability or right of an attorney, legal aid bureau or law school clinical program, to seek attorney fees, expenses or costs from any adverse party, which may include compensation for student services:

- (g) certify in writing that he or she has read and will comply with the American Bar Association Model Code of Professional Responsibility; and
- (h) certify in writing that he or she has read the Rules of the United States Court of International Trade, the evidentiary rules relevant to the action or proceeding in which he or she is appearing, and this Administrative Order.

## 3. The law student may:

- (a) appear as counsel in Court or at other proceedings, accompanied by the supervising attorney, when written consent of the client, the supervising attorney, and the assigned judge have been filed with the Clerk of the Court; and
- (b) prepare and sign motions, petitions, answers, briefs and other documents in connection with any matter in which he or she has met the conditions of Section 3(a) above; provided that each such document also shall be signed by the supervising attorney.
- 4. The attorney who supervises a student shall:
  - (a) be a member of the bar of the United States Court of International Trade;
  - (b) be a participant in a student clinical program as defined by the law school;
  - (c) assume personal professional responsibility for the student's work;
  - (d) assist the student to the extent necessary;
  - (e) appear with the student in all proceedings before the Court;
  - (f) indicate in writing his or her consent to supervise the student; and

- sign any motions, petitions, answers, briefs, and other (g) documents in connection with any matter in which a student appears as counsel in Court or at other proceedings.
- The judge's consent for the student to appear may be withdrawn without notice or hearing and without the showing of cause. The withdrawal of consent by a judge shall not be construed to reflect on the character or ability of the student.
- Forms for certifying compliance with this Administrative Order shall be available in the Office of the Clerk of the Court. Completed forms shall be filed with the Clerk of the Court.
- This Administrative Order shall take effect on February 1, 2006 and may be amended by the Court from time to time on the Court's own initiative. This Administrative Order shall apply to all proceedings in actions brought after its effective date and all further proceedings in actions then pending.
