

#### Interior Mission

The Department of the Interior (DOI) is the nation's principal conservation agency. #### A Large, Decentralized Organization








#### **Education is Key!**

  - "Tell me what we have, where it is at, who is using it, and that it is meeting the mission."


#### And Tomorrow:

  - Control thy destiny through...PARTICIPATION




#### **Change Vendor Expectations**
