

'Free Map Monday' Rules

No purchase necessary.

Eligibility - Free Map Monday (the "Contest") is open only to legal residents of the fifty (50) United States (including the District of Columbia), Canada and Mexico.

Subject to all applicable federal, state, provincial, municipal, territorial and local laws and regulations.

Sponsor - U.S. Geological Survey, Central Region Geospatial Information Office, Box 25286, Denver, CO, 80225, U.S.A.

Winners are not endorsed by USGS, or the Department of the Interior.

How to Enter - Enter 'Free Map Monday' (the 'Contest') by following @USGSstore on twitter.

Winner Requirements – Each winner will be notified by Direct Message on twitter, and well as announced via "tweet." Winner will select one (1) prize not to exceed \$20.00 in value from the U.S. Geological Survey online store at store.usgs.gov. Winner will have a 30 day period to claim prize by calling 1-888-MAP-DEAL (1-888-627-3325) and identifying self as 'Twitter Winner." At time of prize-claiming phone call winner may purchase additional products using a credit card. Handling fees for claimed prize and additional products at time of call will be waived. These rules do not apply to subsequent phone calls from Winner/Customer.

If prize chosen is less than the allotted amount, there is no credit issued. Additional amount is waived. **If chosen** product exceeds allotted prize amount, winner is responsible for additional amount.

Selection of Winners - will be determined according to the process set forth below. All eligible "followers" will be entered into a randomization program and chosen by a computer.

Limit - Each participant may win one (1) time per each 180 day period.
