SUBJECT: Off-Limits Establishment Policy

1. References:

- a. Army Regulation 190-24, Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations
- b. COMNAVREG MIDLANT SOPA (ADMIN) HAMPTON ROADS NOTICE 1620 (dated 7 Mar 2012)
- 2. Purpose: To notify the Fort Lee community of identified establishments operating in the Virginia area that are declared "Off-Limits" to Armed Forces personnel.

3. Policy:

- a. Scope: This policy applies to:
 - (1) All Armed Forces personnel assigned or attached to Fort Lee.
- (2) All Armed Forces personnel in TDY Status at Fort Lee in which the TDY orders specifically states, for UCMJ purposes, Armed Forces personnel are attached to Fort Lee.
- (3) All sister services assigned or attached to Fort Lee as long as the policy is signed by the Commanding General.
- b. General: The Fort Lee Armed Forces Disciplinary Control Board has adopted the recommendations of the Joint Armed Forces Disciplinary Control Board for Southeastern Virginia and Northeastern North Carolina area. The board has placed the following businesses and establishments "OFF LIMITS" to all personnel.
