

## Angela N. Hrdlicka



Angela Hrdlicka is a Special Agent (SA) with the Department of the Interior Office of Inspector General (OIG), and has been detailed to the Inspector General Criminal Investigator Academy (IGCIA) as the Executive Director since August 2006. The IGCIA is a key component of the Council of the Inspectors General for Integrity and Efficiency's (CIGIE) Training Institute. SA Hrdlicka is responsible for the development, implementation and administration of training for the investigative staff of the CIGIE membership, which includes more than 70 federal OIGs. The IGCIA also provides IG-specific training to various state/local and military Inspector General personnel.

SA Hrdlicka began her law enforcement career in 1990 as a criminal investigator with the U.S. Secret Service (USSS) in the Washington Field Office. She conducted a variety of investigations, including major economic crimes such as bank and access device fraud, counterfeit currency investigations, forgery of U.S. Treasury obligations, food stamp fraud and identity theft. During numerous protective intelligence investigations of individuals and groups that posed potential threats to USSS protectees, SA Hrdlicka acquired expertise in conducting interviews of mentally ill subjects. She conducted frequent and diverse protective advance assignments in the U.S. and abroad, often utilizing her Russian language skills in doing so. In 1997, SA Hrdlicka was assigned to the Intelligence Division in USSS headquarters, where she performed many foreign and domestic protective intelligence advance missions for the President and Vice-President of the United States. SA Hrdlicka was subsequently assigned to the James J. Rowley Training Center (RTC), as an instructor responsible for the protective intelligence curricula in the Special Agent Training Course (SATC). In 2001, she was transferred to the RTC office at the Federal Law Enforcement Training Center (FLETC) as the program manager of the SATC counterfeit curricula, where she developed, implemented and taught an innovative 7-day block of instruction. In 2003, she was promoted to Assistant Special Agent in Charge, and was responsible for managing all USSS training, staff and students at the FLETC.

SA Hrdlicka currently serves as the First Vice-Chair of the Federal Law Enforcement Training Accreditation (FLETA) Board. She has been an active participant in the FLETA Board's activities since 2003 when she served on the original Standards Steering Committee, and has also been an Assessor, and member of the Strategic Planning and Bylaws committees. She is also a member of the Board of Directors of the Association of Inspectors General. She received her Bachelor of Arts degree in political science and comparative area studies (Russia and Latin America) from Duke University in 1988. She resides in Brunswick, Georgia, with her husband and two sons.
