MANUFACTURED ABRASIVES IN THE THIRD QUARTER 2011

The U.S. Geological Survey (USGS) collects quarterly data on manufactured abrasives through its survey of producers. Manufactured abrasives included in this report are fused aluminum oxide, silicon carbide, and metallic abrasives. Where indicated, Canadian and United States data are combined to protect proprietary information. Except where noted, the quantities cited in this report are in metric units. All unit value calculations in this report are based on unrounded data.

Fused Aluminum Oxide

The United States and Canadian combined production during the third quarter of 2011 was estimated to be 5,000 metric tons (t) of regular-grade crude fused aluminum oxide with an estimated value of \$800,000, which was essentially unchanged in quantity and value from that of both the third quarter of 2010 and second quarter of 2011. One company, operating one plant in Canada and one in the United States, produced fused aluminum oxide. These production figures have been rounded to the nearest 5,000 t to avoid disclosing proprietary data.

According to the U.S. Census Bureau, U.S. imports of crude fused aluminum oxide during the third quarter of 2011 were 47,200 t valued at \$30.0 million, or an average of \$635 per ton. About 72% of the imports came from China, 23% from Venezuela, 4% from Canada, and 1% from other countries.

U.S. imports of ground and refined fused aluminum oxide for the third quarter of 2011 were 9,750 t valued at \$13.6 million, or an average of \$1,400 per ton.

U.S. exports of crude fused aluminum oxide for the third quarter of 2011 were 5,710 t. These exports were valued at \$21.7 million, or \$3,790 per ton. Canada received 46% of the exports that were shipped; Mexico, 16%; Germany, 14%; Korea, 6%; United Kingdom, 4%; Japan, 4%; and others, 10%. U.S. exports of ground fused aluminum oxide for the third quarter of 2011 were 404,000 t valued at \$207 million, or \$514 per ton. Canada received 58% of the exports that were shipped; Iceland, 23%; Netherlands, 7%; Georgia, 6%; Mexico, 2%; and others, 4%.

Silicon Carbide

Abrasive-grade silicon carbide is produced by one company in the United States. The total production of abrasive-grade silicon carbide during the third quarter of 2011 was estimated to be 10,000 t, with an estimated value of \$7.4 million, which was essentially unchanged in quantity and value from that of both the third quarter of 2010 and second quarter of 2011. These production figures have been rounded to the nearest 5,000 t to avoid disclosing proprietary data.

Total U.S. imports of crude silicon carbide during the third quarter of 2011 were 17,300 t valued at \$21.1 million; imports from China alone were 6,980 t valued at \$9.01 million. The average price of imported crude silicon carbide, excluding Chinese crude, was \$1,170 per ton; the average price of Chinese crude was \$1,290 per ton. U.S. imports of ground and refined silicon carbide for the same period were 8,620 t valued at \$22.5 million, or an average of \$2,610 per ton. During the third quarter of 2011, China accounted for 40% of the crude material and 40% of the ground and refined material imported.

U.S. exports of crude silicon carbide during the third quarter of 2011 were reported to be 6,550 t with a value of \$10.1 million. Third quarter exports of ground and refined silicon carbide were 2,350 t valued at \$7.19 million. About 99% of the crude material was shipped to, in decreasing order of quantity, Norway, Germany, Thailand, Korea, Italy, and Mexico. About 96% of the refined material was shipped to, in decreasing order of quantity, Germany, Canada, Thailand, Mexico, China, Brazil, and Japan.

Metallic Abrasives

Metallic abrasives information was collected from 10 companies operating 11 U.S. plants. During the third quarter of 2011, five companies produced 53,700 t of steel shot and grit, a 31% increase compared with that of the same period in 2010, because of the continued recovery from the economic recession. At least one of the companies produced shot and grit from reclaimed material. Total third quarter 2011 production was valued at \$27.1 million, or an average of \$505 per ton. Total

production in 2010 was 166,000 t valued at \$81.3 million. Total production in 2009 was 137,000 t valued at \$64.9 million.

Shipments of steel shot and grit in the third quarter of 2011 were 53,900 t valued at \$28.4 million, or an average of \$526 per ton, compared with shipments during the third quarter of 2010, which were 46,400 t valued at \$27.2 million for an average of \$587 per ton.

During the third quarter of 2011, five companies produced 490 t of other types of metallic shot and grit (primarily cut wire shot) valued at \$1.68 million.

Imports of all types of metallic shot and grit during the third quarter of 2011 were 24,400 t valued at \$14.3 million for an average of \$587 per ton, compared with imports during the third

quarter of 2010, which were 13,300 t valued at \$7.15 million for an average of \$537 per ton. Sweden, Canada, Korea, Germany, China, and Japan were the leading suppliers, accounting for 78%, 10%, 4%, 2%, 2%, and 2% of the tonnage imported, respectively.

Exports of all types of metallic abrasives during the third quarter of 2011 were 10,300 t valued at \$15.6 million, or an average of \$1,510 per ton, compared with exports during the third quarter of 2010, which were 9,090 t valued at \$13.0 million, or an average of \$1,430 per ton. Shipments to Mexico accounted for 43% of the exports; an additional 26% was shipped to China and 20% was shipped to Canada.
