

# Intra-HHS Collaborations Report for FY 2006

## Background

This National Institutes of Health report to the Secretary, U.S. Department of Health and Human Services is in response to Section 104 of P.L. 109-482, the National Institutes of Health Reform Act of 2006, enacted on January 15, 2007, which establishes a new Section 403A(a) in the Public Health Service Act that requires the Director of the National Institutes of Health (NIH) to submit an annual report to the Secretary of Health and Human Services (HHS) on NIH activities involving collaboration with other HHS agencies.

NIH's collaborative efforts with her sister agencies are a critical component of the HHS mission to protect the health of all Americans and provide essential human services, especially for those who are least able to help themselves. As the Nation's leading medical and behavioral research institution, NIH is dedicated to the pursuit of fundamental scientific knowledge about living systems and the application of that knowledge to improve people's health and reduce the burden of disease. Our collaborations with HHS agencies promote the translation of NIH's research to community health practice, coordinate a range of health programs and policies, enable better tracking of patient safety initiatives, and optimize agency efforts to reduce health disparities.

Many of these NIH/HHS collaborative efforts are longstanding – some begun more than 45 years ago – and continue today. As an example, the Lipid Standardization Program<sup>1</sup> (LSP) began as a collaboration with the Centers for Disease and Prevention (CDC) in 1961 with a goal to improve the laboratory measurement of cholesterol, triglycerides, high-density lipoprotein cholesterol (HDL-C), and low-density lipoprotein cholesterol (LDL-C). This standardized measurement not only led to the accuracy and precision needed to reliably detect, treat, and prevent cardiovascular disease, but LSP continues today to provide standardization services to over 100 participating laboratories.

## Scope of Report

The NIH Institutes and Centers (ICs) and the Office of the Director (OD) reported 587 collaborative efforts with 12 HHS agencies that were ongoing in FY 2006. The NIH funding contribution for FY 2006 totaled \$357,718,674, and NIH funding for these 587 collaborations in the five year period from 2002-2006 totaled \$1,232,871,625 [Figure 1]. The categories of collaborations include Committees/Meetings, Disease Registries, Health Surveys, Information Clearinghouses, Public Education Campaigns, Research Initiatives, Training Initiatives, and Workgroups/Workshops [Figure 2]. There were a total of 240 funded and 347 non-funded collaborations. The non-funded collaborations rely chiefly on NIH's intellectual input, typically in the form of committees. Indeed, nearly half of all collaborations occur through Committees/Meetings and Workgroups/Workshops [Figure 2; Table 1]. In addition to the collaborative efforts identified in Table 1, NIH supports other HHS programs through mandates such as the PHS Act Section 241 Evaluation Set-Asides, which totaled \$613M in FY2006.

The collaborative HHS agencies include the Administration for Children and Families (ACF), Agency for Healthcare Research and Quality (AHRQ), Administration on Aging (AoA), Agency for Toxic Substances & Disease Registry (ATSDR), Centers for Disease Control and Prevention (CDC), Centers for Medicare and Medicaid Services (CMS), Food and Drug Administration (FDA), Health Research Services Administration (HRSA), Indian Health Service (IHS), Office of

the Secretary, HHS (OS), Office of the Surgeon General (OSG), and Substance Abuse and Mental Health Services Administration (SAMHSA). While most of the funding for collaborative activities occurred with FDA and CDC [Figure 3], NIH invests in a significant amount of collaborative activity across the spectrum of HHS sister agencies [Figure 4].

The broad range of health care collaborations is evident in Table 1, which lists each activity by category and includes links for additional information. Highlights of this tabulation include collaborative preventive measures and educational activities/studies with the Centers for Disease Control and Prevention (CDC) and the Agency for Healthcare Research and Quality (AHRQ) such as the AIDS Antiretroviral Treatment/Prevention Program, Childhood Immunization Practices, and the Agricultural Health Study. Disease-specific collaborations target Autism, Diabetes, Obesity, Emerging Infectious Diseases, and Mental Health. Other noteworthy collaboration topics include Surveillance Epidemiology and End Results, Equity and Efficiency in Health Care Reform, and Social, Behavioral, and Economic Science approaches to Anti-Terrorism Research and Development<sup>2</sup>.

Certain collaborations provide crucial information that can immediately impact the health of Americans. One example is the collaboration between NIH and AHRQ to develop multiple evidence reviews about cancer health care. These reviews provide patients, policymakers, and other health care leaders with additional knowledge for making critical health care decisions regarding recruitment, dissemination, recommendations, and the efficacy of interventions and treatments<sup>3</sup>. Another example of a collaboration to inform the American public is a research grant between CMS and NIH, which funded a supplementary mail survey on prescription drug use, cost, and satisfaction. This survey also disseminated information prior to the implementation of the Prescription Medicare Part D benefit in order to help educate those qualifying for the program about options that were in their best interests.

Given the complexity of the process of translating a new basic scientific discovery into a readily accessible treatment for Americans, the NIH and its sister HHS agencies realize the strategic importance of these collaborations. Importantly, while many collaborations involve large amounts of funding, many others rely on the exchanges of ideas to deliver the best health care available to the American people. The NIH welcomes this opportunity to report to HHS on the vibrant nature of collaborations within the Department. As our report details, many of these collaborations have been ongoing for over 30 years, and NIH is committed to forming new collaborations when emerging issues and needs arise.

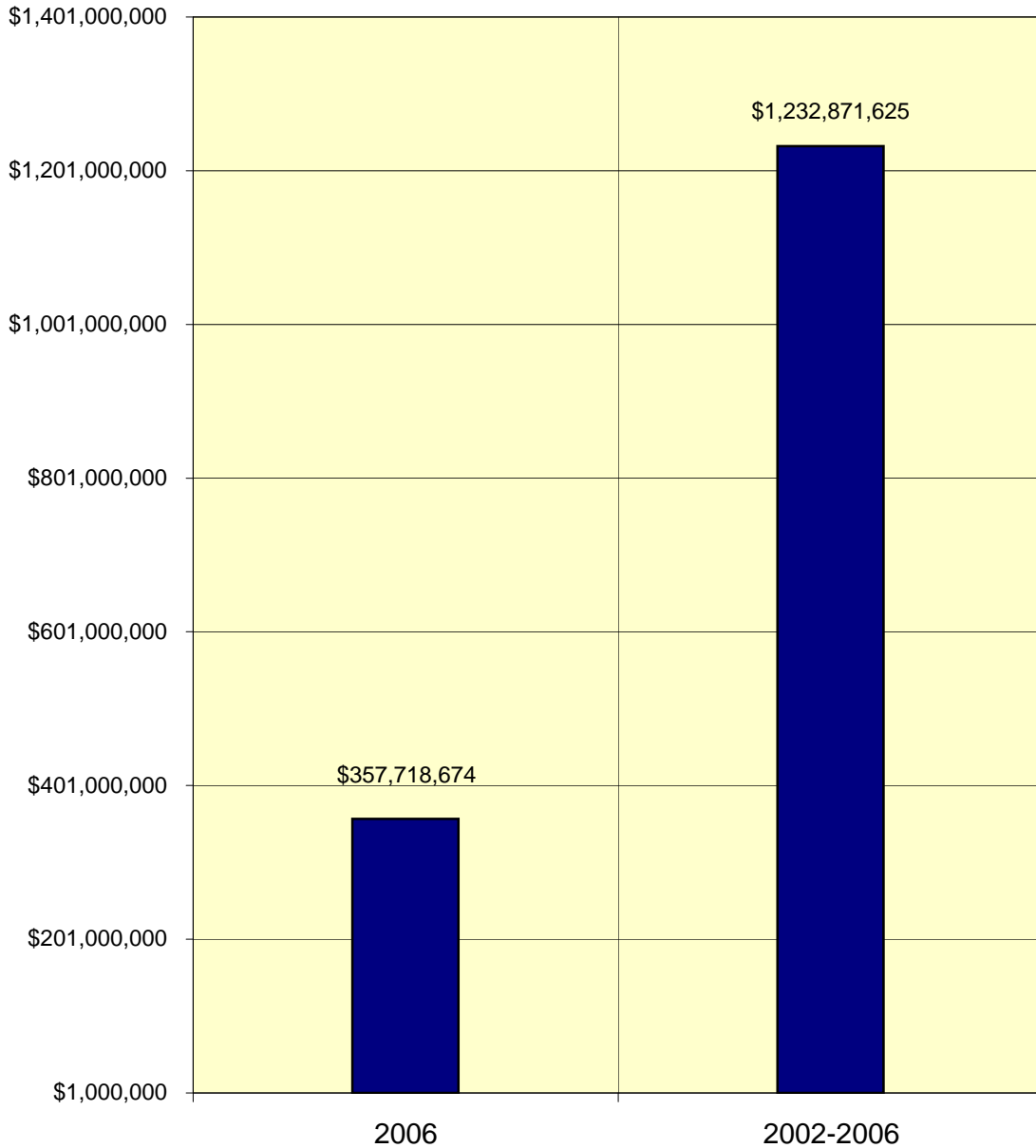

**Figure 1: NIH Funding for Collaborations Ongoing in FY2006\***

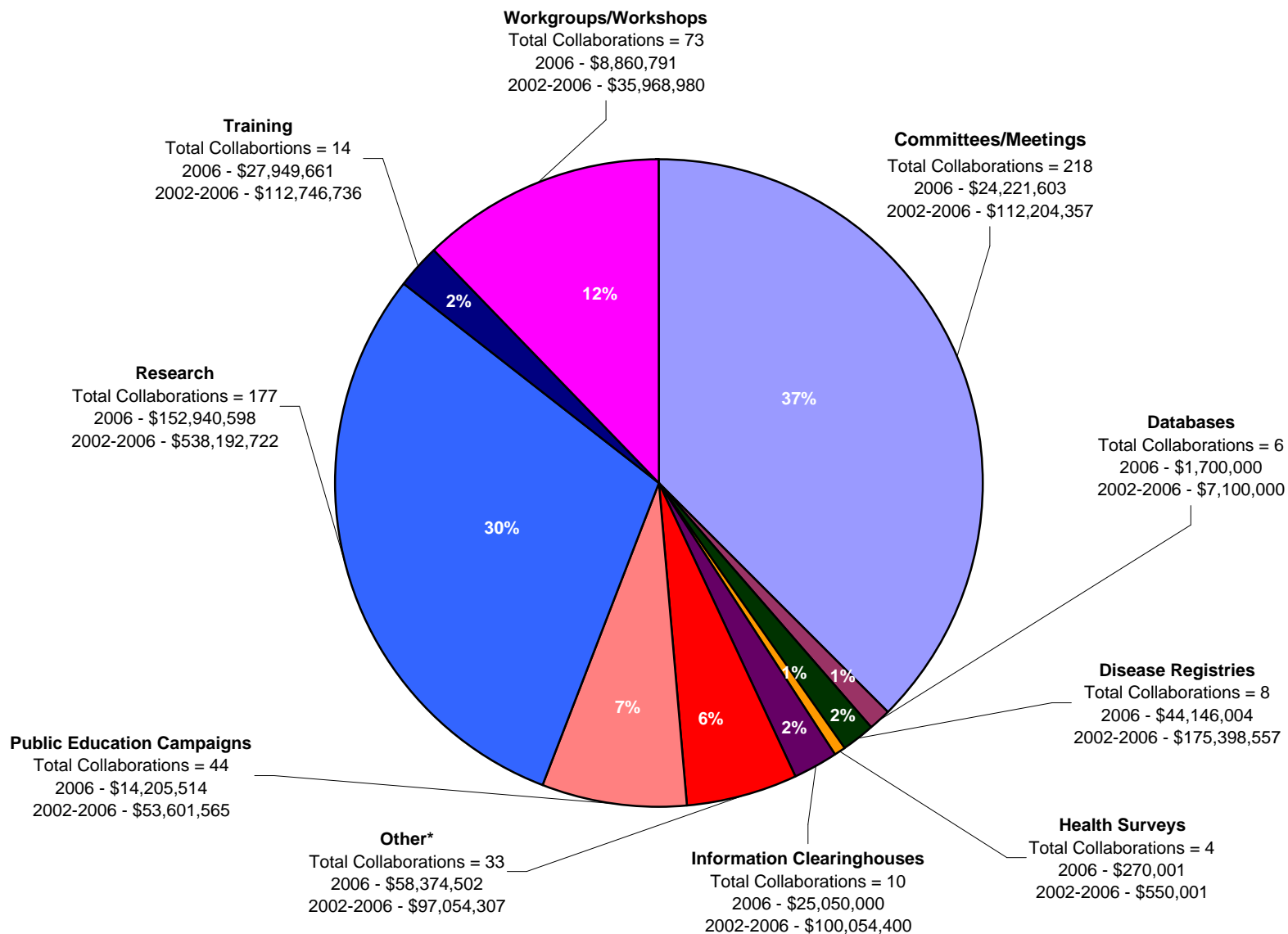

## Figure 2: NIH Collaborative Funding by Categories

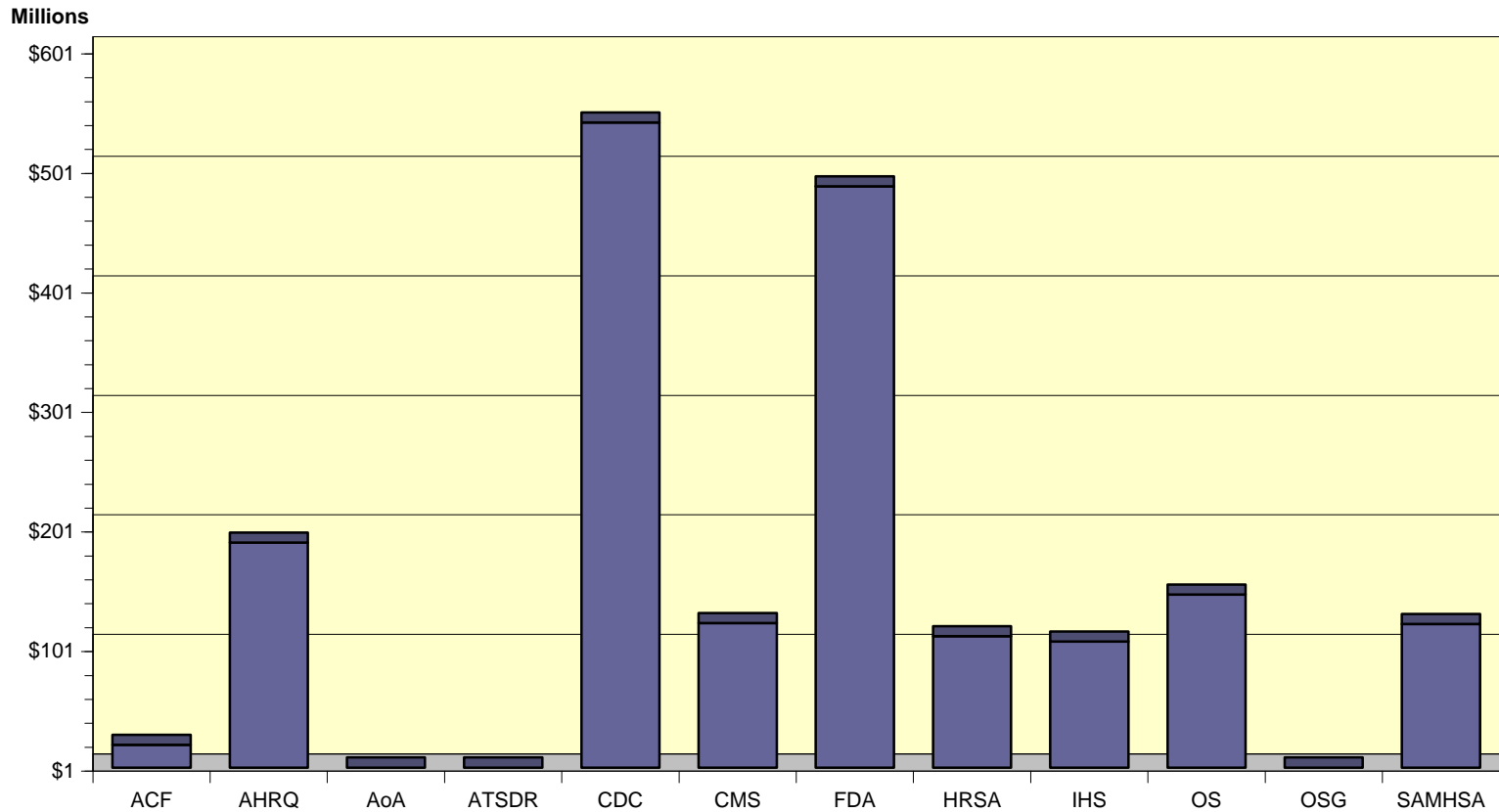

### Figure 3: 2002-2006 NIH Collaborative Funding Contributions with HHS Agencies

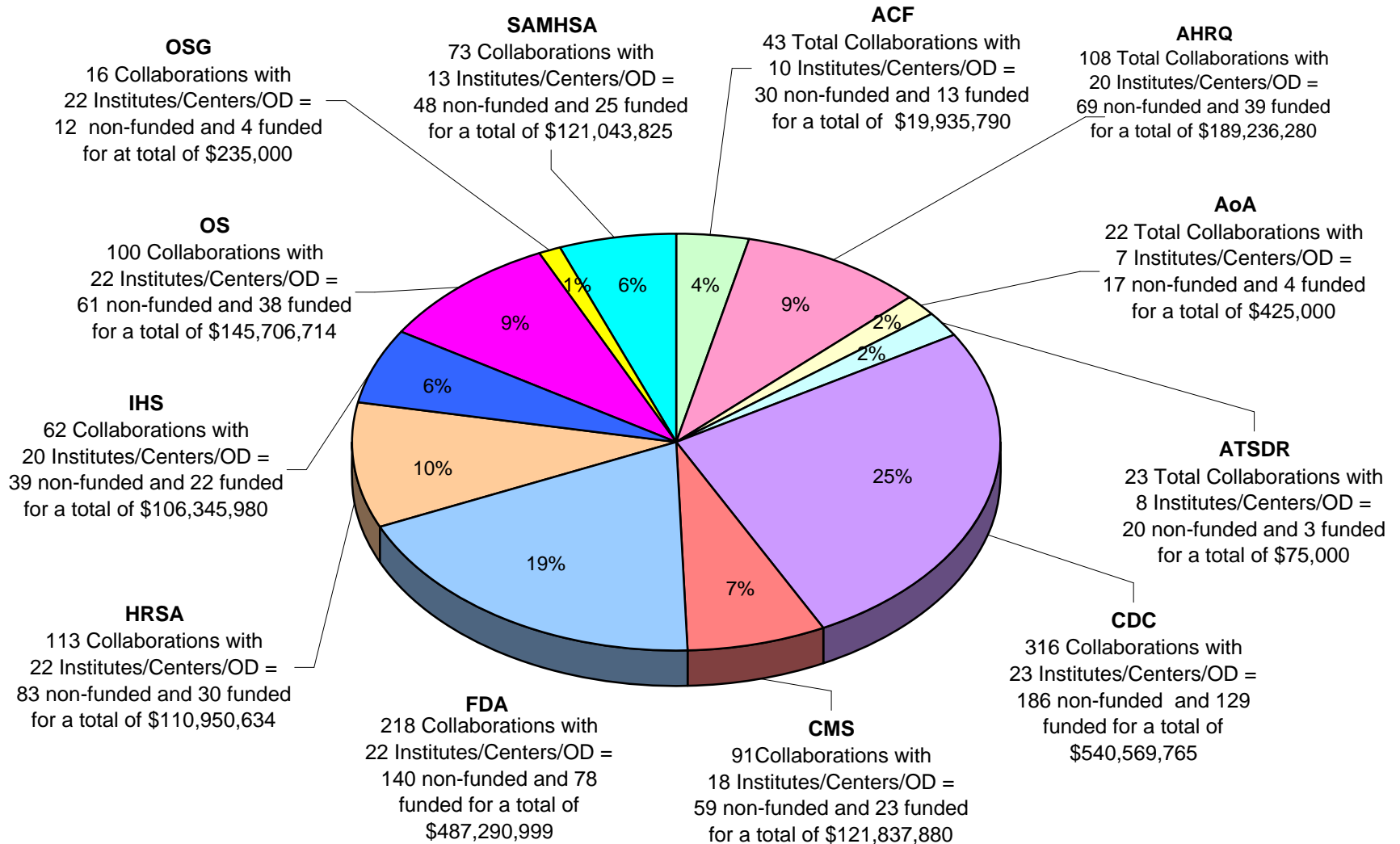

Only collaborations which were ongoing in FY2006 are reflected in this five year period (FY2002-2006). Because many of the 587 collaborations involve multiple HHS agencies, the five year funding levels for each agency are not additive. Total 2002-2006 funding is \$1,232,871,625.
