### **Scope and Content**

The materials in FOIA 2012-0669-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA request 2012-0669-F contains correspondence from members of the military, legislature, and medical professionals in Washington State and California recommending Stanley Flemming to the position of Surgeon General in early 1995. Flemming also wrote expressing his interest in the position. Henry Foster was nominated in 1995 for the position, but never confirmed. Ultimately Audrey Manley was appointed acting Surgeon General from 1995-1997, and in 1998 David Satcher was appointed Surgeon General by President Clinton.

### **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area - Clinton Presidential Records: WHORM Subject Files.

The White House Office of Records Management (WHORM) Subject file was compiled by the White House Office of Records Management and is a series of categories designated by a letter/number combination. WHORM files are processed at the document level.
